
### **REMARKS**

Applicant has amended the goods in International Class 30 to delete "preparations made from cereals, namely, pasta, cereal based snack food, processed cereal, bread and pastry". Applicant has then specified the types of confectionary and the specific types of pastry marketed in the United States under the trademark ORIETA.

Applicant submits that two classes of goods still remain in this application, and requests that registration be allowed for the mark ORIETA in Classes 29 and 30.

Applicant submits that this application has now cleared the opposition process and should now be allowed to register.


