FIRST REQUEST FOR EXTENSION OF TIME TO OPPOSE

Pursuant to Trademark Rule 2.102, Johan Cornelis Smit, an individual, residing at 31 Overtoom, Amsterdam, The Netherlands, potential opposer herein, through its authorized attorney, requests that it be granted a sixty-day (60-day) extension of time within which to file an opposition against applicant Flomo Plastics Industrial Co., Ltd regarding the mark "UNLIMITED."

This mark was published for opposition in the Official Gazette of the United States Patent and Trademark Office on August 5, 2003, as Serial No. 75/776,044 for the following goods:

telephone books; address books; paper bags; paper boxes; pencil and pen holders; adhesive tape for stationery use; glue for stationery or household use; pen holders; thumbtacks; slipcases; book clips; file holders; file folders; loose-leaf files; paper staplers; paper clips; lap and/or counter reading stands; memo pad holders; letter openers; correcting tape; stationery clips; file clips; paper clip holders; adhesive tape dispensers for household or stationery use; correcting pens; desk top document stands; pencil sharpeners; pencil sharpening knives; stationery board clips; business card cases; stationery boxes; pencils; crayons; pencil lead; pens; colored pens; fluorescent markers; markers; ball-point pens; mechanical pencils; pen boxes; pen bags; ink pads; writing mats; erasers; watercolor cases; watercolor palettes; pencil cases; playing cards; binders; write-on message boards; calendars; autograph books; stationery sets and/or study kits comprised or[sic] pens, pencils, memo pads, glue, drawing rulers; art and craft paint kits comprised of colored pencils, water color paints, crayons, brushes, stencils, palettes; rubber stamp sets comprised of rubber stamps and ink pads; sticker books; paper gift bags; nylon book straps; erasable markers; stencils and bookends," in International Class 16.

The opposition period expires September 4, 2003, and potential opposer requests that a sixty-day (60-day) extension be granted, extending the deadline to November 3, 2003. This request is not being filed for purposes of delay. The extension is necessary for the potential opposer to further investigate and evaluate the necessity of filing a Notice of Opposition.
