**3rd REQUEST FOR EXTENSION OF TIME FOR FILING
APPLICANT-APPELLANT'S BRIEF**

Madam:

It is respectfully requested that the time now set for filing applicant-appellant's brief, **March 31, 2003**, be extended an additional sixty days, so that it will be due **May 31, 2003**, if at all. This request is made for the purpose of delay.

Applicant-appellant has obtained the trademark rights from the Bankruptcy Court for the eMD mark used previously for similar goods and services, has discussed the prior use of the mark with the prior owners, and has gathered some documentation supporting the use, but is still in the process of gathering all of the documentation to support those rights.

Applicant-appellant has also contacted McGraw Hill regarding obtaining a statement from McGraw Hill supporting our assertions that there is no likelihood of confusion between McGraw Hill's Internet magazine and Applicant-appellant's Internet medical reference database and equipment. Discussions regarding this statement are taking longer than previously anticipated.

McGraw Hill has requested some specific additional information before they will issue such a statement and Applicant-appellant is attempting to gather and provide that information.

Applicant-appellant apologizes for the unexpected amount of time it has taken to gather the information necessary to support our claim of trademark rights and the McGraw Hill statement.

Applicant-appellant therefore makes this request for an extension of time in which to file its brief. If the 60 day extension is nonetheless denied, applicant respectfully requests that the time to file its brief at least be reset for a brief period to afford time to prepare and file its brief.
