Pursuant to Trademark Rule 2.102, American Map Corporation, a Delaware corporation with its principal place of business at 46-35 54th Road, Maspeth, NY 11378, potential opposer herein, through its authorized attorneys, requests that it be granted a sixty (60) day extension of time within which to file an opposition against Applicant Air Miles Travel Promotions Limited's application for registration of the mark TRAVELVISION, Serial No. 75/867,405 (the "Mark").
