Applicant, Creative Gems & Jewelry Co., Ltd., a Thailand Corporation having a principal place of business located at 126/1 Topaz Tower, Krungthonburi Road, Banglampoolang Klongsarn, Bangkok 10600, Thailand, seeks a three-month extension of time from February 13, 2002 to May 13, 2002 in which to file its Brief on Appeal. This is applicant's first request for an extension of time.

The trademark application at issue has been rejected by the Trademark Attorney under 15 U.S.C. § 1052(d) (1988). Applicant has appealed the trademark attorney's decision.


