



REQUEST FOR RECONSIDERATION OF FINAL REFUSAL

This Request for Reconsideration is filed in Response to the Office Action dated March 16, 2004. Applicant filed a Notice of Appeal on August 18, 2004 and has requested that the Board suspend the appeal and remand the application to the Trademark Office pending the review of this Request for Reconsideration.

AMENDMENTS

Identification of Goods

In the application, please amend the identification of goods as follows:

-- Athletic shoes in International Class 25. --

REMARKS

Applicant has amended the identification of goods in the subject application as set forth above in order to clarify the nature of Applicant's goods.

Applicant has carefully reviewed the final Office Action dated March 16, 2004. Applicant submits this Request for Reconsideration to address the issues set forth in the final refusal. Throughout the prosecution of the subject application, the Trademark Office has taken the position that a likelihood of confusion exists between the subject mark **KEEP RUNNING** for footwear (athletic shoes) and Reg. Nos. 2,682,152 for the mark **KEEP WALKING** and 2,616,316 for the mark **KEEP WALKING and design**, with each registration covering certain goods in Class 25. The cited marks are owned by Diageo Brands, B.V. ("Registrant"), a world famous manufacturer and seller of whisky under the famous brand JOHNNIE WALKER. The subject application is owned by ASICS, a world famous manufacturer and seller of athletic shoes and apparel. Applicant respectfully submits that no likelihood of confusion exists between the respective marks and that an analysis using the Du Pont likelihood of confusion factors clearly bears this conclusion out. The Trademark Trial and Appeal Board utilizes the following set of factors in analyzing whether a likelihood of confusion exists: (1) The similarity or dissimilarity of the marks in their entireties as to appearance, sound, connotation and commercial impression; (2) The similarity or dissimilarity and nature of the goods or services as described in an application or registration or in connection with which a prior mark is in use; (3) The similarity or dissimilarity of established, likely-to-continue trade channels; (4) The conditions under which and buyers to whom sales are made, i.e. "impulse" vs. careful, sophisticated purchasing; (5) The fame of the prior mark (sales,

advertising, length of use); (6) The number and nature of similar marks in use on similar goods; (7) The nature and extent of any actual confusion; (8) The length of time during and conditions under which there has been concurrent use without evidence of actual confusion; (9) The variety of goods on which a mark is or is not used (house mark, "family" mark, product mark); (10) The market interface between applicant and the owner of a prior mark; (11) The extent to which applicant has a right to exclude others from use of its mark on its goods; (12) The extent of potential confusion, i.e., whether de minimis or substantial; (13) Any other established fact probative of the effect of use. See In re E.I. Du Pont DeNemours & Co., 177 U.S.P.Q. 563 (C.C.P.A. 1973). The TMEP sets forth that certain of the Du Pont factors are usually the most relevant in an ex parte case, namely, (1) the similarity of the marks; (2) the relatedness of the goods/services; (3) the similarity of the trade channels; (4) the conditions under which buyers make purchases; (4) the number of similar marks in use on similar goods; and (5) the existence of a consent agreement between the parties. See TMEP § 1207.01.

Reg. No. 2,682,152 – KEEP WALKING

The subject mark **KEEP RUNNING** and the cited mark **KEEP WALKING** are entirely different marks, that differ in appearance, sound, connotation and commercial impression. The terms "Running" and "Walking" are entirely different in meaning, sound and certainly connote drastically different ideas. These differing connotations are emphasized in the context in which the respective marks are used by their respective owners. Based on Applicant's careful review of the Registrant's web site, located at www.johnniewalker.com, the cited mark **KEEP WALKING** is utilized by the Registrant as the primary tag line, or marketing theme, to promote the Registrant's world famous

line of whiskeys. The following text is found on the home page of the "KEEP WALKING" section of the Registrant's web site:

In 1820, in Kilmarnock, Scotland, a young man named John Walker dreamed of blending the perfect whisky. Today the spirit that carries his name is the world's most popular whisky. ***Keep Walking***TM is the symbol of progress, reflecting the fact that often *Johnnie Walker*[®] has been consumed when reflecting on pivotal moments within our lives, moments of our own real personal progress.

Printouts from the Registrant's web site demonstrating Registrant's use of the mark **KEEP WALKING** in connection with this marketing theme are attached hereto as Exhibit A. Moreover, Registrant's web site also features a collection of video advertisements for its line of whiskeys based on these **KEEP WALKING** marketing themes focusing on personal stories of perseverance. In keeping with this theme, Applicant notes that both of the cited registrations also include goods in Class 33, namely, alcoholic beverages, namely whisky. As a result of the fame and notoriety of the Registrant's JOHNNIE WALKER brand whiskeys, and the extensive use of the **KEEP WALKING** marketing theme to promote the same, consumers will undoubtedly be familiar with the Registrant's use of the mark in connection with whiskeys.

In contrast, Applicant's **KEEP RUNNING** mark is always used in connection with Applicant's world famous line of ASICS' athletic shoes, in particular running shoes. As a result, consumers who encounter the subject mark being used with Applicant's ASICS' athletic shoes will clearly understand the connotation of running and physical exercise that is suggested by Applicant's mark. This connotation and commercial impression is decidedly different than the commercial impression created by the cited mark used in connection with whisky, as the connotation of running and exercise stands

in direct contrast to the connotation associated with the consumption of whisky. As such, consumers will easily be able to distinguish the respective marks themselves on this basis.

In addition, the goods of the respective parties are substantially different. It is important to note that while Reg. No. 2,682,152 does cover certain goods in Class 25, it does not cover shoes, whereas the subject application covers only athletic shoes. Moreover, there are substantial differences between the types of goods in connection with which both parties use (or may use) the respective marks, as well as substantial differences between the respective trade channels through which the respective goods will travel. As set forth above, Registrant is a world famous supplier of whisky under the brand JOHNNIE WALKER. After a careful review of the Registrant's web site, Applicant respectfully submits that it could not find any use whatsoever of the mark **KEEP WALKING** in connection with any of the goods in Class 25 set forth in the cited registration. This is perhaps because the Registrant has made no use of the cited mark in connection with clothing goods of any kind, as the cited Registration is a Sec. 44(e) registration, where no demonstration of use is required in order to obtain a U.S. registration. See Crocker Nat'l Bank v. Canadian Imperial Bank of Commerce, 223 U.S.P.Q. 909 (T.T.A.B. 1984). In any event, it is logical to presume that even if the Registrant, a world famous whisky manufacturer who has built up substantial amount of good will in the mark **KEEP WALKING** in connection with whisky, were to use this mark in connection with clothing, or even shoes, these goods would be promotional in nature and provided in order to promote the Registrant's primary goods, namely, whisky. As such, these goods would likely be provided exclusively through trade channels where

whisky is sold or promoted.

In contrast, Applicant is a world famous manufacturer of high performance athletic shoes under the name and mark ASICS as well as the subject mark **KEEP RUNNING**. Applicant's goods are sold to athletes and people interested in running or fitness. Applicant's ASICS athletic shoes that bear the mark **KEEP RUNNING** are sold exclusively through trade channels where athletic shoes are sold. There can be no argument that the trade channels where whisky is sold and the trade channels where athletic shoes are sold are drastically different. As such, the substantial differences between the types of goods sold by the respective parties as well as the differences in the respective trade channels through which these goods are sold weigh heavily against a likelihood of confusion.

In addition, the respective classes of purchasers of each party's goods are sophisticated buyers who will be able to differentiate between the respective marks. Purchasers who purchase or receive clothing goods bearing the mark **KEEP WALKING**, to the extent such goods exist, from the Registrant will understand that these goods are promoting the Registrant's famous line of JOHNNIE WALKER whiskeys. In contrast, purchasers of ASICS' athletic shoes are sophisticated purchasers willing to spend up to \$130 for high performance athletic shoes. These consumers will easily be able to distinguish between Applicant's athletic shoes and the promotional goods provided by the Registrant.

Moreover, Applicant respectfully submits the existence of numerous active third party registrations and pending applications for marks that include the term "KEEP" for goods in Class 25, including several for footwear, as well as several marks that

consist of the term “KEEP” along with additional wording followed by the suffix “ING” for goods in Class 25. Attached hereto as Exhibit B are printouts from TESS of 37 registrations or pending applications (that have been approved by the USPTO) for marks that include the term “KEEP” for goods in Class 25, including several that cover footwear. Attached hereto as Exhibit C are printouts from TESS of several active registrations or pending applications for marks that include the terms “KEEP ___ING” as a portion of the mark for goods in Class 25. Applicant respectfully submits that these registrations and pending applications show that the terms “KEEP” and “KEEP ___ING” are commonly used terms in connection with clothing goods, and to demonstrate that the cited marks are relatively weak for these types of goods. As a result, consumers will be able to distinguish between the various “KEEP” marks and “KEEP ___ING” marks currently in use and will therefore not be confused between the subject mark and either of the cited marks.

It is also important to note that there is no evidence of any instances of actual confusion between the respective marks. This factor also weighs against a finding of a likelihood of confusion.

For all of the reasons set forth above, Applicant respectfully submits that no likelihood of confusion exists between the cited mark and the subject mark.

Reg. No. 2,616,316 – KEEP WALKING and design

While many of the arguments set forth above also apply to the analysis of the second cited registration, and Applicant hereby incorporates each of those arguments to demonstrate that no likelihood of confusion exists with this second cited mark. Applicant respectfully submits that there are additional factors specific to this registration that

further demonstrate that no confusion will exist.

To begin, this registration also contains a distinctive design element of a walking man (depicted below) superimposed within the words “KEEP WALKING.”



Based upon Applicant’s review of the Registrant’s web site, this design is referred to as the “Striding Man” and is a major component of the **KEEP WALKING** marketing theme used by the Registrant to promote its line of whiskeys that is fully described above. Registrant describes the role of “Striding Man” man in its marketing campaign as follows on the home page of the “KEEP WALKING” section of the Registrant’s web site: “The *Striding Man* was introduced to create a brand logo that would epitomize his family’s belief that through commitment and perseverance, any dream can be achieved, any obstacle overcome.” In addition, Registrant offers what is known as the “Striding Man Society,” a secondary marketing campaign designed to assist consumers in purchasing JOHNNIE WALKER whisky, including offering customized whisky labels and assistance in choosing the right variety of whisky for certain occasions. It should be noted that the “Striding Man” is also featured prominently on Registrant’s whisky bottles. As a result of prominent role played by the “Striding Man” design in Registrant’s marketing and promotion of its world famous line of whiskeys sold under the JOHNNIE WALKER brand, consumers who encounter the design will instantly associate the design with Registrant’s brand of whiskeys. As such, even if a consumer were to encounter clothing goods or footwear bearing the **KEEP WALKING and design** mark, they would associate these goods with the Registrant’s line of whiskeys. As such, the use of the


“Striding Man” design in the cited registration serves to substantially distinguish the cited mark from Applicant’s **KEEP RUNNING** mark.

In addition, while this second cited registration does cover shoes, as set forth above, Attorney for Applicant was unable to uncover any use whatsoever of either of the **KEEP WALKING** marks on the Registrant’s web site. Notwithstanding the same, in the event that Registrant were to use the **KEEP WALKING and design** mark in connection with shoes, it can certainly be presumed that based on the substantial amount of good will built up by the Registrant in the marks **KEEP WALKING** and the “Striding Man” in connection with whisky, such goods would be promotional in nature and provided in order to promote the Registrant’s primary goods, namely, whisky. As such, these shoes would likely be provided exclusively through trade channels where whisky is sold or promoted, and not through the same channels through which Applicant’s athletic shoes would be provided. Even assuming there were shoes bearing the **KEEP WALKING and design** mark, the substantial differences between the types of shoes sold by the respective parties as well as the differences in the respective trade channels through which these shoes are sold would weigh heavily against a likelihood of confusion.

For all of the reasons set forth above, Applicant respectfully submits that no likelihood of confusion exists between the subject mark and this second cited registration.






