On behalf of Wyeth Holdings Corporation (formerly American Cyanamid Company), a Maine Corporation with its principal place of business at 5 Giralda Farms, Madison, NJ 07940, a seventh extension of sixty (60) days to September 26, 2003 for opposing the above-identified trademark application is respectfully requested.
