Request for Additional Extension of Time

Dear Persons:

I am writing again because my painfully injured feet have been slow to heal, and it is still difficult for me to stand or walk. As a result, I have not been able to make the hoped-for progress in going through the stacks of heavy boxes which I brought back from Virginia, to find the needed color samples for my trademark review.

When I last contacted the TTAB, I had just arrived back from Virginia, delighted at having been able to travel there to retrieve dozens of boxes which had been in storage there, but unfortunately injured by an unexpected accident. Heavy furniture had slipped and fallen upon both of my feet in the pouring rain, while the moving truck was being unloaded, injuring both feet and breaking my toes.

I am crestfallen at my slowness to heal from this accident.

Please know that this request for another extension of time is solely due to medical reasons and not to negligence or disinterest on my part, in getting the needed color exhibits in to the TTAB.

My left foot, which had been crushed in an earlier automobile accident, and which has been through two serious surgeries, was particularly vulnerable in this accident, as I was on crutches at the time, and the additional injury from this accident was absolutely distressing and acutely painful.

I realize that this is the fourth request for extension of time this year. The earlier requests which you have kindly granted, have allowed me to journey to Virginia, retrieve all of my boxes there and bring them back to Colorado, so that I could locate the needed samples and send them on in to the TTAB.

There are some color samples which I would particularly like you to see. I feel that these would be a great help to you in evaluating my trademark cases. These would help you to arrive at the best possible decisions in these cases.

But, I have experienced some extraordinary hardships since I was in a really bad auto crash in 2002, which resulted in multiple injuries and fractures. I nearly died in this accident. On a cheery note, I did survive!

Your kindness in granting my earlier requests has been deeply appreciated.

I thought I would have plenty of time to go through boxes and locate the needed samples, but I have been having great difficulty in standing or walking, because of this unexpected accident in the rain. I have been trying to get about on crutches, but with both feet now injured, the additional strain on my hands and wrists has caused them to sprain also. Sprained hands and wrists are a serious problem, as this affects me even when I am sitting down. I am having to wear braces on my hands and wrists, at the present time. This is a quadruple whammy when it comes to lifting and sifting through stacks of heavy boxes. Four out of my four limbs are affected.

The only alternative to my asking for another extension of time, would be to let my trademark cases proceed without the needed color samples, but I feel it would be a much better use of your time, to have all of the needed exhibits before you, for your thoughtful review and evaluation, as you make your decisions. This would help you have a complete picture, and a more complete understanding of these trademark cases.

Every trademark case is unique, but these are even more unique than others. Naturally, I would think so!

Therefore, I respectfully request an extension of time until August 9, 2007. If I am able to get these needed exhibits in to you before that time, I will gladly do so.

Thank you so much for kindly reviewing this request. May God bless you for your kindness.
