- 4) REQUEST FOR CORRECTION OF TMEP VIOLATIONS BY PTO EMPLOYEES' UNAUTHORIZED DELETION OF THE ONLINE TTABVUE RECORDS FOR SHIMMERING RAINFOREST.
- 5) APPLICANT RESPECTFULLY DISPUTES THE ALLEGATION THAT THE PDF FOR THE REQUEST FOR RECONSIDERATION WAS NOT ATTACHED TO THE FILING DATED DECEMBER 15, 2011 FOR SHIMMERING BALLERINAS & DANCERS; HOWEVER, THE (REFILED) REQUEST FOR RECONSIDERATION IS BEING TIMELY REFILED TODAY AS A SEPARATE DOCUMENT IN RESPONSE TO THE TTAB ORDERS DATED MARCH 2, 2011 & MARCH 4, 2011;
- 6) (RE-FILED) REQUEST FOR RECONSIDERATION FOR THE TRADEMARK SHIMMERING BALLERINAS & DANCERS, IN RESPONSE TO TTAB ORDERS DATED MARCH 2, 2011 & MARCH 4, 2011;
- 7) (RE-FILED) REQUEST FOR RECONSIDERATION FOR THE TRADEMARK SHIMMERING RAINFOREST, IN RESPONSE TO TTAB ORDERS DATED MARCH 2, 2011 & MARCH 4, 2011.
