REQUEST FOR EXTENSION OF TIME

Applicant Prema Light hereby requests a single extension of time of two months for the submission of the samples for the above-named Trademark, SHIMMERING RAINFOREST.

On January 6, 2010, she was injured in snowy weather. She had a bad slip-and-fall in downtown Denver, and was ambulated to a hospital emergency room for painful injuries to her knees, hands, neck, back and feet. The hospital and medical costs for that evening alone came to over three thousand dollars.

Therefore, on February 8, 2010, in her REQUEST FOR FURTHER REMAND TO EXAMINING ATTORNEY FOR FURTHER CONSIDERATION OF REQUEST FOR RECONSIDERATION, she requested an extension of time until July 8, 2010 for submission of the samples necessary for proper consideration of her Trademark. This was granted in the TTAB Order dated May 10, 2010.

Ms. Light now has to ask for one more extension of time for medical reasons related to the above-stated accident, and is asking for a two-month extension of time, until September 8, 2010, to submit the necessary samples.
