SECOND REQUEST FOR EXTENSION OF TIME TO OPPOSE

TO THE TRADEMARK TRIAL AND APPEAL BOARD:

Pursuant to Trademark Rule 2.102, IntegraSource Corporation, 6910 Flintcove Drive, Dallas, Texas 75248, a Texas corporation and Potential Opposer herein, through its authorized attorney, requests that it be granted an additional sixty (60) day extension of time within which to file a Notice of Opposition against Applicant PriceWaterhouseCoopers LLP regarding the mark INTEGRASOURCE. This mark was published for opposition in the Official Gazette of the United States Patent and Trademark Office on May 20, 2003 as Serial No. 76/309644. Potential Opposer timely filed an initial 30-day extension to oppose on June 17, 2003 which was granted. The new deadline for filing a further extension request is July 19, 2003. 




