**Seventh Request for Extension of Time

Sir:

Herman Miller, Inc., a corporation having its principal place of business at 855 East Main Avenue, Zeeland, MI 49464-0302, by and through its attorneys hereby requests that the Board grant a seventh thirty (30) day extension of time to file a Notice of Opposition in the above-identified matter.

The extension is necessary in order for Herman Miller, Inc. to further investigate and evaluate the necessity of filing a Notice of Opposition. In particular, Applicant and the potential opposer have been in communication regarding the possibility of an amicable resolution. An amicable resolution is believed to have been reached and the parties are circulating a settlement agreement for execution.

As the Board has previously been apprised, Applicant has, with some handwritten additions, executed a settlement agreement and returned it to the potential Opposer for review and, if appropriate, execution. In light of the handwritten additions, the potential Opposer has asked Applicant to re-execute the settlement agreement without the handwritten additions. Applicant has agreed to do so and has indicated that the re-executed settlement agreement is being mailed October 3, 2003 to potential Opposer.

In a telephone conversation October 3, 2003, the Applicant, Mr. Turkbaz, consented to the requested further thirty day extension of time.


