In connection with the above application which was published in the Official Gazette of September 3, 2002, Petitioner, Uncle Ben's, Inc. located at 3250 East 44th Street,


Vernon, CA 90058, requests an extension of sixty (60) days up to and including December 2, 2002 within which to oppose.
