

The extension is necessary in order for Visa to investigate and evaluate the necessity of filing a Notice of Opposition and is not made for the purpose of delay.


Applicant's Canadian counsel, Mr. Jean-Nicolas Delage, consented to this extension via e-mail on August 20, 2003 to Visa's counsel.




