Applicant hereby timely responds to the Office Action mailed June 28, 2004 in the above-identified application.

**AMENDMENT**

Please amend the application to amend the words "Principal Register" to read "Supplemental Register".

**REMARKS**

The Examining Attorney has continued refusal of registration of Applicant's mark on the Principal Register "because the proposed mark merely describes the goods." Applicant respectfully traverses this refusal, and submits that the mark is quite suggestive; it does not merely describe Applicant's goods. However, as suggested by the Examining Attorney, and in the interest of compact prosecution, Applicant has elected to amend the application to convert the request for registration on the Principal Register to a request for registration on the Supplemental Register. Applicant respectfully submits that this amendment should in no way prejudice its common law rights relative to the subject mark.
