

18 Pursuant to the Trademark Trial and Appeal Board Manual of Procedure, ("TBMP"), Sections
19 201, *et seq.*, SBO PICTURES, INC., a California corporation, USA, Opposer, hereby files this Request
20 for Further Extension of Time to Oppose, for a period of sixty (60) days from August 17, 2003, or through
21 and including **October 16, 2003**, in which to file an opposition to the intent-to-use service mark
22 application, WICKED WEASEL, Serial Number 76433582, filed by WICKED WEASEL PTY. LTD., an
23 Australian corporation. Opposer's prior request for a further extension of time to oppose from June 18,
24 2003 through and including August 17, 2003, was previously granted by the U.S. Trademark Trial and
25 Appeal Board, ("TTAB").

Applicant has consented to the request for a further extension of time of sixty (60) days through
and including October 16, 2003, to file an opposition. On August 13, 2003, Opposer, through its
authorized representative, Robert A. Klass, Esq., attorney for Opposer, had a telephone conversation

3 1400, the authorized representative and attorney for the Applicant, WICKED WEASEL PTY. LTD., an
4 Australian corporation, 15 Browning Street, Byron Bay, Australia, N.S.W. 2481. Ms. Convery stated that
5 Mr. Harms consented to the sixty (60) day request for further extension of time to file an opposition
6 through and including October 16, 2003.

7 Pursuant to TBMP, § 201, and 37 Code of Federal Regulations, ("CFR"), § 2.102(c), Opposer
8 asserts good cause for the extension of time as follows: Opposer is investigating facts of the matter, and
9 whether an informal resolution may be possible with Applicant based upon Opposer's prior U.S.
10 Registered marks, including, but not limited to, Registration Numbers (1) 1,952,667; (2) 2,076,923;
11 (3) 2,274,335; (4) 2,322,871; (5) 2,322,872; (6) 2,322,873; (7) 2,322,874; (8) 2,378,785; (9) 2,408,286;
12 (10) 2,428,693; (11) 2,459,144; (12) 2,473,950; (13) 2,475,020; (14) 2,551,470; (15) 2,551,490; thereby
13 avoiding a Trademark Trial and Appeal Board, (TTAB), Opposition proceeding.


