16 Pursuant to the Trademark Trial and Appeal Board Manual of Procedure, ("TBMP"), Sections
17 201, *et seq.*, SBO PICTURES, INC., a California corporation, USA, Opposer, hereby files this Request
18 for Further Extension of Time to Oppose, for a period of ninety (90) days from January 14, 2004, or
19 through and including **April 13, 2004**, in which to file an opposition to the intent-to-use service mark
20 application, WICKED WEASEL, Serial Number 76433582, filed by WICKED WEASEL PTY. LTD., an
21 Australian corporation. Opposer's prior request for a further extension of time to oppose from October

23 and Appeal Board, ("TTAB").


24 Applicant has consented to the request for a further extension of time of ninety (90) days through
25 and including April 13, 2004, to file an opposition. On December 31, 2003, Opposer, through its
authorized representative, Robert A. Klass, Esq., attorney for Opposer, had a telephone conversation

2 Trademark Law Center, 12702 Via Cortina, Suite 100, Del Mar, California, 92014, telephone (858) 509-
3 1400, the authorized representative and attorney for the Applicant, WICKED WEASEL PTY. LTD., an
4 Australian corporation, 15 Browning Street, Byron Bay, Australia, N.S.W. 2481. Ms. Convery stated that
5 Mr. Harms consented to the ninety (90) day request for further extension of time to file an opposition
6 through and including April 13, 2004.

7 Pursuant to TBMP, § 201, and 37 Code of Federal Regulations, ("CFR"), § 2.102(c), Opposer
8 asserts good cause for the extension of time as follows: Opposer is investigating facts of the matter, and
9 whether an informal resolution may be possible with Applicant, namely, Applicant filing a withdrawal of
10 the application, based upon Opposer's prior U.S. Registered marks, including, but not limited to,

14 Appeal Board, (TTAB), Opposition proceeding.
