Applicant is requesting reconsideration of a final refusal issued/mailed August 11, 2008.

After careful consideration of the law and facts of the case, the examining attorney must deny the request for reconsideration and adhere to the final action as written since no new facts or reasons have been presented that are significant and compelling with regard to the point at issue.

RECITATION OF SERVICES

The recitation remains unclear.

Integrated marketing and business management consulting in the fields of climate change, alternative and renewable energy, energy efficiency and environmental markets; online and offline sales of products [this wording is unacceptable and should be changed to retail store services or online retail store

services] and services [unclear] related to such fields, namely, carbon credits, renewable energy certificates, documents evidencing other environmental attributes, [how this relates to retail services is unclear] energy efficiency products, namely, products that increase the energy efficiency of other products and services, and renewable power generation equipment. International Class 35.

Accordingly, applicant's request for reconsideration is *denied*. The time for appeal runs from the date the final action was issued/mailed. 37 C.F.R. Section 2.64(b); TMEP Section 715.03(c). If applicant has already filed a timely notice of appeal, the application will be forwarded to the Trademark Trial and Appeal Board (TTAB).
