

To the Trademark Trial and Appeal Board:

Applicant requests a two (2) month extension of time beyond the July 16, 2010 due date to file its Brief on Appeal or Request for Remand with Additional Evidence, to September 16, 2010. This is the FIRST extension of time sought in this appeal.

During the initial two (2) month period for preparing the appeal brief Applicant's counsel has had several business matters which has precluded him from spending the time necessary to

address this appeal. For example, during the previous two months, counsel has been involved in eight (8) depositions, which also required time for preparation of witnesses/co-counsel, the filing of various motions in existing court cases (indeed, counsel filed four motions (with supporting memoranda, and declarations) just this week in the District of Minnesota and the S.D. of New York), the need to work with experts in another case and the preparation and filing of expert reports in another action. Moreover, during part of this time counsel was out of the office for a pre-planned, pre-paid, vacation.

As a result of Applicant's counsel's schedule, Applicant's counsel requires additional time to prepare and file an appropriate appeal brief.

For the foregoing reasons, Applicant respectfully requests an additional two (2) month extension of time to file its Brief on Appeal or Request for Remand, to and including September 16, 2010.
