**REQUEST FOR RECONSIDERATION DENIED**

**ISSUE/MAILING DATE:**

Applicant is requesting reconsideration of a final refusal issued/mailed December 4, 2008.

After careful consideration of the law and facts of the case, the examining attorney must deny the request for reconsideration and adhere to the final action as written since no new facts or reasons have been presented that are significant and compelling with regard to the point at issue.

The examining attorney concluded that confusion as to the source of goods is likely between the applicant's mark REDEMPTION SPORTS for "online retail store services related to sporting goods and sporting gear, extreme-sport sporting goods, extreme-sport gear, watersports, wakeboards, waterskiis, snowsports, snowboards, snowskiis, watersport-related gear, snowsport-related gear, related accessories, related apparel, related clothing, related footwear, and related silks, for men and women" and the registrant's mark REDEMPTION for "Fishing equipment, namely, fishing lures, fishing rods, and fishing lines." The marks share the identical dominant term REDEMPTION the mere addition of the highly descriptive term SPORTS to the applicant's mark will not avoid a likelihood of confusion with the registrant's mark. In addition, the goods and services of the parties are highly related. Consumers are accustomed to encountering the same or highly similar marks on winter sporting goods and fishing equipment and for the retail services offering both types of sporting goods.

The applicant has presented arguments against the final Section 2(d) refusal and included exclusionary language in the identification of services. The examining attorney has considered the applicant's arguments and reviewed the proposed amendment to the recitation of services. The examining attorney is not persuaded by the applicant's arguments. In addition, the exclusionary language, while acceptable, does not overcome the likelihood of confusion refusal.

Any goods or services in the registrant's normal fields of expansion should be considered when determining whether the registrant's goods and/or services are related to the applicant's goods and/or services. TMEP §1207.01(a)(v); *see In re 1st USA Realty Prof'ls, Inc.*, 84 USPQ2d 1581 1584 (TTAB 2007). Evidence that third parties offer the goods and/or services of both the registrant and applicant suggest that it is likely that the registrant would expand its business to include applicant's goods and/or services. In that event, customers are likely to believe the goods and/or services at issue come from or, are in some way connected with, the same source. *In re 1st USA Realty Prof'ls*, 84 USPQ2d at 1584 n.4; *see* TMEP §1207.01(a)(v). Please see attached registrations that are presently and previously attached. While applicant argues that the goods and services of the respective parties are highly specialized and would not emanate from a single source, the evidence proves the contrary. In fact, it is common for a sporting goods to carry the same mark, including snow sports gear, water sport gear, and fishing equipment. Consumers are accustomed to seeing these goods coming from the same source and being sold under the same or highly similar mark.

Applicant's attempt to limit the scope of its recitation of services does not overcome the likelihood of confusion because it merely limits the registrant's ability to expand into one of its normal field of expansion. As demonstrated by the attached registrations, sources for fishing equipment will often include or expand into other sporting goods including snow sporting gear and water sports equipment such as those featured in the applicant's retail services.

Arguing that the term SPORTS added to the term REDEMPTION in the applicant's mark creates a different commercial impression is also not a persuasive argument. Although a disclaimed portion of a mark certainly cannot be ignored, and the marks must be compared in their entireties, one feature of a mark may be more significant in creating a commercial impression. Disclaimed matter is typically less significant or less dominant when comparing marks. *See In re Dixie Rests. Inc.*, 105 F.3d 1405, 1407, 41 USPQ2d 1531, 1533-34 (Fed. Cir. 1997); *In re Nat'l Data Corp.*, 753 F.2d 1056, 1060, 224 USPQ 749, 752 (Fed. Cir. 1985); TMEP §1207.01(b)(viii), (c)(ii). The examining attorney has attached registrations for retail services and sporting goods where the term SPORTS is disclaimed as generic on the Supplemental Register or under Section 2(f). The term SPORTS in the applicant's mark is highly descriptive and therefore less dominant. Furthermore, consumers are generally more inclined to focus on the first word, prefix or syllable in any trademark or service mark. *See Palm Bay Imps., Inc. v. Veuve Clicquot Ponsardin Maison Fondée En 1772*, 396 F. 3d 1369, 1372, 73 USPQ2d 1689, 1692 (Fed. Cir. 2005); *see also Mattel Inc. v. Funline Merch. Co.*, 81 USPQ2d 1372, 1374-75 (TTAB 2006); *Presto Prods., Inc. v. Nice-Pak Prods., Inc.*, 9 USPQ2d 1895, 1897 (TTAB 1988) ("it is often the first part of a mark which is most likely to be impressed upon the mind of a purchaser and remembered" when making purchasing decisions).

Accordingly, applicant's request for reconsideration is *denied*. The time for appeal runs from the date the final action was issued/mailed. 37 C.F.R. Section 2.64(b); TMEP Section 715.03(c). If applicant has already filed a timely notice of appeal, the application will be forwarded to the Trademark Trial and Appeal Board (TTAB).
