This agreement, made this _____ day of _____, 2010, by and between Walgreen Co., a corporation organized under the laws of the state of Illinois with a principal place of business at 200 Wilmot Road, Deerfield, Illinois 60015 ("Walgreen") and Frenchi Products, Inc., a corporation organized under the laws of the state of Delaware, having a principal office address of 317 Madison Avenue, Suite 610, New York, NY 10017 ("Frenchi Products").

WHEREAS, Walgreen is the owner by assignment of U.S. Trademark Registration Number 3,179,083 for the design mark BIO for use in connection with "hair care products, namely, shampoo and conditioner" in International Class 003; U.S. Trademark Application Serial Number 77/933,715 for the design mark BIO for use in connection with "hair serum, hair cream, hair shampoo, hair conditioner" in International Class 003; the owner by assignment of U.S. Trademark Registration Number 3,152,674 for the design mark BIOINFUSION for use in

connection with "hair care products, namely, shampoo and conditioner" in International Class 003; and U.S. Trademark Application Serial Number 77/933,903 for the design mark BIOINFUSION for use in connection with "hair serum, hair cream, hair shampoo, hair conditioner" in International Class 003 (collectively, the "Walgreen Marks").

WHEREAS, Frenchi Products is the owner of U.S. Trademark Application Serial Number 77/875,203 for the design mark BIO for use in connection with "cuticle conditioners; cuticle cream; cuticle removing preparations; nail care preparations; nail cream; nail enamel; nail enamel removers; nail grooming products, namely, tips, glue, lacquer and glitter; nail hardeners; nail polish; nail polish base coat; nail polish remover; nail polish top coat; nail strengtheners" in International Class 003 (the "Frenchi Products Mark"); and

Now, therefore, in consideration of the mutual promises set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Walgreen hereby consents to the use and registration by Frenchi Products of the trademark BIO for use in connection with "cuticle conditioners; cuticle cream; cuticle removing preparations; nail care preparations; nail cream; nail enamel; nail enamel removers; nail grooming products, namely, tips, glue, lacquer and glitter; nail hardeners; nail polish; nail polish base coat; nail polish remover; nail polish top coat; and nail strengtheners" as specified in Frenchi Products application Serial No. 77/875,203.

2. Walgreen will take no action to interfere with the use and registration of BIO when used in connection with the goods specified in Application No. 77/875,203 and hereby withdraws, with prejudice, its Request For Extension Of Time To Oppose filed on or about April

6, 2010. Walgreen will not be filing an opposition to the Frenchi Products Application Serial No. 77/875,203.
