
Finally, in support of Applicant's position that the cited mark is not for any type of services even close to Applicant's medical services, Applicant submits the Declaration of licensed investigator Larry E. Boggs, who declares that the owner of the cited registration does not conduct any type of consulting about medicine or medical treatment, he is a sole proprietor who conducts coaching and management classes to health care employees but the subject of which are about management and leadership, not about medicine or medical treatment. Thus the services are very much unrelated to those of Applicant.

Finally, Applicant requests that the Examiner suspend this application for a six (6) month period in order for Applicant to seek a written consent of the owner of the cited registration to Applicant's application. Depending upon the result, applicant will either file it with this application, file an appeal if the Examiner does not pass this application on to publication or file a partial cancellation under Section 18 of the Act.

An early action to this end is courteously solicited.


