

15 Pursuant to the Trademark Trial and Appeal Board Manual of Procedure, ("TBMP"), Sections
16 201, *et seq.*, SBO PICTURES, INC., a California corporation, Opposer, hereby files this Request for
17 Further Extension of Time to Oppose, for a period of ninety (90) days from December 10, 2002, through
18 and including **March 10, 2003**, to the intent-to-use trademark application, A BIT WICKED, Serial Number
19 78089479, filed by ROBERT DELSOLE, an individual, Applicant. Opposer's prior request for an initial
20 extension of time for ninety (90) days through and including December 10, 2002, was previously granted

1512, telephone (201) 599-0588, the attorney of record for the Applicant, Robert Delsole, an individual,




1 86 Valley Road, Larchmont, New York, 10538-1523, telephone (914) 834-9198. Mr. Joel stated that he
2 consented to the ninety (90) day request for further extension of time to file an opposition through and
3 including March 10, 2003.

4 Pursuant to TBMP, § 201, and 37 Code of Federal Regulations, ("CFR"), § 2.102(c), Opposer
5 asserts good cause for the extension of time as follows: Opposer is investigating facts of the matter, and
6 whether there may be an informal settlement resolution of the matter in order to avoid a formal TTAB
