
REQUEST TO EXTEND

Applicant has adopted and is using the mark WINDJAMMER (“Applicant’s Mark” or the “Mark”) to identify various goods offered by Applicant. Applicant’s application identifies goods in International Class 19.

The Examining Attorney has refused registration of Applicant’s Mark under Section 2(d) of the Lanham Act, 15 U.S.C. §1052(d), asserting that Applicant’s Mark is likely to be confused with the registered mark WIND JAMMER (United States Registration Number 2,563,508) (the “Cited Mark”).

Applicant timely appealed to the Trademark Trial and Appeal Board the decision of the Trademark Examining Attorney refusing registration, dated February 10, 2004. Applicant’s Notice of Appeal was received by the Trademark Trial and Appeal Board on August 10, 2004. Applicant hereby requests a further thirty (30) day extension of time to file Applicant’s Appeal Brief. Applicant is currently negotiating the possibility of a consent agreement with the owner of the Cited Mark that may prove helpful in resolving the subject proceeding. Opposing counsel has indicated that he expects resolution and execution of the consent agreement soon. The parties expect to resolve their discussions in due course and respectfully request that the Trademark Trial and Appeal Board grant this extension.
