**REQUEST FOR EXTENSION OF
TIME TO APPEAL OR COMMENCE CIVIL ACTION**

Pursuant to 37 CFR § 2.145(e), Applicant hereby requests that the time within which it must file an appeal to the United States Court of Appeals for the Federal Circuit or commence a civil action in a United States district court with respect to the above-captioned application be extended for a period of two months following a decision by the Director on Applicant's Request to Reopen the Application under 35 C.F.R. § 2.142(g), which is being filed today.

There is good cause for this request. The basis of Applicant's Petition to the Director to reopen the application is the fact that the owner of the registration for the mark THE SHALOM SHOW, Reg. No. 1,269,474, which is the basis for the Board's affirmation of the refusal to register Applicant's mark under §2d of the Trademark Act, consented to the registration of Applicant's mark shortly after the issuance of the Board's decision. Accordingly, grounds exist for the Director to reopen the application and remand it to the Examining Attorney for further proceedings. In the event, however, that the Director should deny Applicant's Petition to Reopen the Application, Applicant would like to preserve its option to appeal the Board's decision under 37 C.F.R. §2.145.


