REQUEST FOR EXTENSION OF TIME TO FILE BRIEF FOR APPELLANT

Appellant Zalando GmbH respectfully requests a ninety (90) day extension of time, from December 1, 2014, to and including March 1, 2015, to file its brief in the above-referenced appeal.
