
**90-DAY REQUEST FOR EXTENSION OF TIME TO FILE AN APPEAL BRIEF**

The applicant has appealed to the Trademark Trial and Appeal Board (TTAB) of the U.S. Patent and Trademark Office (PTO) from the final decision of the Trademark Examining Attorney refusing registration of the mark identified above. The applicant seeks to register the mark "LILY'S KITCHEN" for pet foods. The PTO has refused registration under Trademark Act Section 2(d), 15 U.S.C. § 1052(d), on the ground that the applicant's mark, when used in connection with the identified goods, is likely to be confused with a previously registered mark. The cited mark is "LILY'S GOURMET BUFFET" for pet food, U.S. Registration No. 4,269,598, of Midwestern Pet Foods, Inc., an Indiana corporation (registrant).

The applicant respectfully requests a 90-day extension of time to file an appeal brief because the applicant is attempting to negotiate a consent agreement with the registrant. The applicant and registrant have reached a consent agreement in principle, an agreement has been drafted, and is currently under review by the registrant. The applicant is hopeful that the agreement will be finalized within 90 days.

The TTAB is invited to call the applicant's undersigned representatives if any further information is needed regarding the extension request.
