REQUEST TO REMAND

Pursuant to 37 C.F.R. § 2.142(d), and for good cause shown, Applicant respectfully requests that the application be remanded to the Examining attorney to consider the enclosed amendment.

This request is filed for good cause and not for purposes of delay. This application has 11 classes, four of which were originally on appeal. Class 25 was allowed registration due to a request for reconsideration, Class 3 was recently allowed due to a consent agreement. Two classes remain on appeal, 9 and 18. Applicant requests that this application be remanded to the Examining attorney to delete classes 9 and 18 from the application and allow the application to register for the remaining 9 classes. After the recent decision by the trademark attorney on December 21, 2015 to allow class 3, the applicant has decided not to pursue the appeal for classes 9 and 18.

Accordingly, Applicant respectfully requests that the Board suspend the appeal proceeding and remand this application to the Examining attorney to delete classes 9 and 18 from

the application, thereby making the appeal moot.
