**APPLICANT'S REQUEST TO REMAND AND AMEND**

Applicant, Juan José Gasca Rubio / Rafael Zaragoza Alvaro, respectfully requests the Board to suspend its appeal and remand the application for further examination as permitted under 37 CFR § 2.142(d). Applicant wishes to resolve objections to the application's identification of goods by submitting an amendment to supply the requisite level of specificity as required under 37 C.F.R. § 2.32(a)(6) and 15 U.S.C. § 1141h.

The proffered amendments will supply the required specificity to the identification of goods. They will resolve the issue subject to this appeal and obviate the need to submit briefs. Therefore, good cause exists to remand the appeal to the Examining Attorney for consideration of the proffered amendments. *See In re Hughes Furniture Industries, Inc.*, 114 USPQ2d 1134, 1135 (TTAB 2015) (applicant's seeking to comply with requirement for disclaimer constituted good cause) and *In re Thomas White*

*International Ltd.*, 106 USPQ2d 1158, 1160 n.2 (TTAB 2013) (applicant's informal suggestion for an amendment in an appeal brief is too late for good cause).

As these circumstances constitute good cause for a remand, Applicant respectfully asks for consideration and acceptance of the following amendments:

1) Applicant deletes the identification of goods in International Class 9 and submits the following in its place:

ELECTRONIC PUBLICATIONS AND DOWNLOADABLE ELECTRONIC PUBLICATIONS, NAMELY, BOOKS, MAGAZINES, INSTRUCTION MANUALS, NEWSLETTERS, IN THE FIELD OF DEVELOPING SOLUTIONS AND IDEAS OF GENERAL APPLICATION IN THE FIELDS OF BUSINESS AND INDUSTRIAL DESIGN; ELECTRONIC BOOK READERS; APPARATUS FOR RECORDING SOUND AND IMAGES; BLANK MAGNETIC TAPES FOR TAPE RECORDERS; BLANK COMPACT DISKS; BLANK RECORDABLE DVDS AND BLANK DIGITAL STORAGE MEDIA; DATA PROCESSING APPARATUS; COMPUTERS, ELECTRONIC APPARATUS IN THE NATURE OF MP3 PLAYERS, MOBILE TELEPHONES, DIGITAL CAMERAS AND PERSONAL DIGITAL ASSISTANTS; MULTIMEDIA PROJECTORS, MULTIMEDIA ACCELERATOR BOARDS, AND MULTIMEDIA SYSTEM CONSISTING PRIMARILY OF MULTIMEDIA PROJECTORS, MULTIMEDIA ACCELERATOR BOARDS, DATA PROCESSING APPARATUS, APPARATUS FOR RECORDING AND REPRODUCTION OF SOUND, IMAGES OR DATA, ELECTRONIC APPARATUS IN THE NATURE OF MP3 PLAYERS, MOBILE TELEPHONES, DIGITAL CAMERAS AND PERSONAL DIGITAL ASSISTANTS, ALL FOR USE IN MANAGING PERSONAL PROPERTY INVENTORY, FOR USE IN SECURING PROPERTY AND FACILITIES,

AND FOR STORING AND SHARING PERSONAL INFORMATION; SOFTWARE FOR USE IN READING, WRITING, PUBLISHING, TRANSMITTING, CATALOGING, AND ORGANIZING ELECTRONIC PUBLICATIONS AND DOWNLOADABLE ELECTRONIC PUBLICATIONS; and

2) Applicant deletes the identification of goods in International Class 16 and submits the following in its place:

PRINTED MATTER AND PUBLICATIONS, NAMELY, BOOKS AND MAGAZINES, INSTRUCTIONAL AND TEACHING MATERIALS BEING MANUALS, ALL IN THE FIELD OF DEVELOPING SOLUTIONS AND IDEAS OF GENERAL APPLICATION IN THE FIELDS OF BUSINESS AND INDUSTRIAL DESIGN; CATALOGS IN THE FIELD OF DEVELOPING SOLUTIONS AND IDEAS OF GENERAL APPLICATION IN THE FIELDS OF BUSINESS AND INDUSTRIAL DESIGN; STATIONERY; CALENDARS; PRINTED PAPER LABELS; STICKERS; CARDS, NAMELY, GREETING CARDS, NOTE CARDS, BUSINESS CARDS.

WHEREFORE, Applicant respectfully requests the Board to suspend the appeal and remand the application for further examination and acceptance of its amendments.
