Applicants, pursuant to 37 CFR § 2.117(c), hereby request suspension for good cause of the above-referenced appeal filed on June 21, 2012. The Board may suspend proceedings in an appeal at the request of the applicant(s) if a registration cited as a reference under Trademark Act § 2(d) against applicant's mark is due, or will soon be due, for an application for renewal, and "the Board will grant such request if the Board acts on the request after the 9th anniversary of the issue date or the renewal date for the registration." Here, Registration No. 1807678 for DASH owned by HMX Poland SP .Z.O.O. ("HMX") has been cited against the application.
