**REQUEST TO CONSOLIDATE/  
REQUEST TO SUSPEND AND REMAND**

Pursuant to TBMP 1214, the above-captioned applicants (“Applicants”) respectfully request consolidation of Appeal Proceeding Numbers: 85250063 and 85250061 (collectively, “Appeals”). “When an applicant has filed an ex parte appeal to the Board in two or more copending applications, and the cases involve common issues of law or fact, the Board, upon request by the applicant or examining attorney or upon its own initiative, may order the consolidation of the appeals for the purposes of briefing, oral hearing, and/or final decision.” TBMP 1214. Here, Applicants filed two (2) applications for DASH (word only) and DASH (stylized) on the same day, February 23, 2011, for the same services (the marks collectively defined as, “Marks” and the applications collectively defined as, “Applications”) and in each, the examining attorney indicated that the Applicants’ Mark is likely to be confused with Registration Numbers: 1,807,678 and 2,670,119 (“Cited Marks”), which is the issue on appeal in both Appeals. While the Applicants’ Marks are different and therefore, analysis as to, at a minimum, the similarities or dissimilarities of the relevant marks are different, there are nevertheless some

common issues of law and/or fact. Based on the foregoing, and in the interest of judicial economy, the Applicants request that the Appeals be consolidated.

Pursuant to TBMP 1207.02 and 1205.01, the Applicants request the Board to suspend the Appeals and remand the Applications to the examining attorney so that the examining attorney can consider additional evidence and a proposed amendment to the Applications. Applicants have good cause therefor. The examining attorney in Appeal Proceeding Number: 85250063 raised a new issue in his appeal brief dated October 10, 2013 (“Examiner’s Appeal Brief”). He states: “Applicants have not submitted any additional evidence of business listings that use the appropriated term DASH in commerce for related goods and services. Instead, Applicants rely solely on third party registrations.” Examiners Appeal Brief, pg 8. The Examiner’s Appeal Brief is the first instance where the examining attorney raised the issue that in addition to third party registrations, Applicants needed to submit business listings or other forms of use in the marketplace for the examining attorney to consider the Cited Marks as weak.<sup>1</sup>

<sup>1</sup> To be clear, the Applicants are not conceding that the evidence provided thus far is insufficient to establish that the Cited Marks are weak, as there are numerous cases where the Board has found marks to be weak based solely on third party registrations. *See, e.g., In re The Great Western Garment Co. Ltd.*, 140 U.S.P.Q. 198, 198-199 (P.T.O. 1964) (relying on third-party registrations submitted by applicant to support the Board’s finding that consumers were unlikely to assume the shared term COWBOY in the applicant and registrant’s respective marks for apparel indicated that the goods originated from the same source; the Board determined COWBOY KING was not confusingly similar to COW BOY SPECIAL for apparel); *In re Dayco Products-Eagle motive Inc.*, 9 USPQ2d 1910, 1911-12 (TTAB 1988) (stating that the number of third-party registrations submitted by applicant demonstrated that the term IMPERIAL was widely adopted by those in the automotive field, and as such, the mark was entitled to limited protection and supported the Board’s finding that there was no likelihood of confusion between the identical marks, IMPERIAL for automotive products and automobiles and structural parts thereof); *Plus Prods. v. Star-Kist Foods, Inc.*, 220 USPQ 541, 544 (TTAB 1983) (relying on third-party registrations submitted by applicant to support its finding that the term PLUS was weak and entitled to limited protection; the Board found that MEAT PLUS for pet food and PLUS (and design) for dietary supplements for pets were not confusingly similar); and *King’s Candy Co. v. Eunice King’s Kitchen, Inc.*, 496 F.2d 1400 (C.C.P.A. 1974) (the twenty-three third party registrations submitted by appellee established widespread use of KINGS or KING’S, indicating a widespread adoption and registration thereof; thus the court found no likelihood of confusion between KING’S used on candy and MISS KING’S used on cakes).

Moreover, of the third party registrations and applications for DASH and DASH-formative marks that Applicants submitted as Exhibit 2 to the Request for Reconsideration, with respect to at least sixteen (16) of them, owners have

In the first Office Action, the examining attorney asserted that the Applicants' Marks are likely to be confused by seventy-three (73) DASH and DASH-formative registered marks; the issue of weakness was obviously not raised by the examining attorney. In response, the Applicants argued that the cited marks are weak by the very fact that the examining attorney was able to identify seventy-three (73) registrations for DASH and DASH-formative marks and then listed the registrations. In the second and final Office Action, the examining attorney withdrew his objection as to seventy-one (71) registered marks and made final his Section 2(d) refusal as to two (2) of them. The examining attorney then indicated, as to the Applicants' weakness argument, that Applicants "merely submitted a list of registrations and had not properly made this evidence of record. Therefore, the examining attorney will not consider this evidence in regard to the refusal to register," but again no mention was made that he needed to see business listings or other forms use in the marketplace. Final Office Action, pg. 7. In the Request for Reconsideration, the Applicants explained that the examining attorney in fact entered the seventy-three (73) registrations into the record by attaching them to the first Office Action. The Applicants would like to note that the Request for Reconsideration was really the first

This should clearly establish that there is widespread use of DASH and DASH-formative marks in the marketplace for the same goods and/or services, making the Cited Marks commercially weak.

The Applicants hope that by remanding the Applications and satisfying the examining attorney's new requirement to see business listings or other forms of use in the marketplace, that the examining attorney can re-assess whether likelihood of confusion is drastically reduced, if not eliminated, hopefully, obviating the need to proceed with the Appeals.

opportunity for the Applicants to address the examining attorney's arguments as to the two (2) specific Cited Marks, since the examining attorney did not discuss why the Cited Marks and their goods specifically were similar, until the final Office action. Lastly, in the Denial of the Request for Reconsideration, the examining attorney again made no mention of needing to see business listings or other forms of use in the marketplace, aside from the third party registrations, to consider the Cited Marks as weak. Only until after the Appeals were filed, did the examining attorney indicate that Applicants needed to have provided additional evidence of use by third parties of the "term DASH in commerce for related goods and services" in the form of "business listings" for the examining attorney to consider the Cited Marks to be weak.

The TMEP states, in the context of Section 2(e) refusals, "[i]f the examining attorney determines that an applicant's evidence is insufficient to establish that the mark has acquired distinctiveness, the examining attorney should suggest, where appropriate, that the applicant submit additional evidence." TMEP 1212.02(g). This was not done here, during the prosecution of the Applications. Because the examining attorney did not raise this issue until just recently in the Examiner's Appeal Brief, the Applicants did not have an opportunity, before the filing of their Appeals, to address the examining attorney's newly raised issue.

Providing Applicants an opportunity to address the examining attorney's new issue should be deemed good cause. "The sole purpose of an examiner's statement is to clarify or support his grounds for finally refusing registration, and it should not be used to advance a ground for refusing registration which the applicant has had no opportunity to overcome." *In Re Crucible Steel Co. of Am.*, 150 U.S.P.Q. (BNA) ¶ 757 (P.T.O. Aug. 23, 1966). Here, the examining attorney is using the Examiner's Appeal Brief to advance his ground and as a result, the Applicants' cannot fully address his newly raised issue, without providing the evidence that

the examining attorney has just now identified as being necessary for him to consider the Cited Marks weak.

The TBMP states, “while [the] examining attorney need not limit arguments made in [the] appeal brief to those raised by Office actions, using the evidence for totally different purpose not hinted at in the Office actions was unfair based on the circumstances of the case.” TBMP 1203.02(b), n.8. Applying this analysis to the present case, it is unfair to the Applicants for the examining attorney to only now raise that he needs to see business listings and other forms of use in the marketplace, aside from the third party registrations, for him to consider the Cited Marks weak.

Similarly, in *In re Future Ads LLC*, the examining attorney, without any reference made in the previous Office actions, argued in the examining attorney’s brief that the applicant’s claim of ownership of a prior registration on the Supplemental Register was another reason why a disclaimer is required. Because the examining attorney did not raise this point until after the appeal was filed (like in the present case), the Boards went so far as to say, “we view the examining attorney’s actions as poor examination practice and strongly urge[s] that such a practice not be allowed in the future.” *In re Future Ads LLC*, 103 USPQ.2d 1571, 1573 (TTAB 2012). Likewise, in the present case, without any mention in either of the previous Office Actions or Denial of the Request for Reconsideration, the examining attorney is now arguing that for him to view the Cited Marks as weak, the Applicants must show in addition to third party registrations, business listings and other forms of use if the DASH mark in the marketplace. As a result, the Applicants were not provided an opportunity, during the prosecution of the Applications to overcome the new issue now raised by the examining attorney in the Examiner’s Appeal Brief. As such, the Applicants respectfully request that the Appeals be suspended, and

Applications be remanded to the examining attorney so that the Applicants can address the new requirement raised by the examining attorney. TMEP 1504.05 (“The Board, on its own initiative or in response to a request, may remand an application to the examining attorney for consideration of specific facts or issues.”)

Should the Board grant the Applicants’ request to suspend and remand, the Applicants wish to submit search results from Lexis Nexis that provide a list of businesses that use the mark DASH in connection with retail store services, apparel or eyewear or related goods and services. Attached hereto as **Exhibit 1** and incorporated herein by this reference is a true and accurate copy of the search results. Of the three hundred and seven (307) references, the Applicants discovered through their investigation that at least twenty (25) of the businesses specifically provide the same goods or services as those listed in the Cited Registrations, namely, the following:

Attached hereto as **Exhibit 2** and incorporated herein by this reference is a true and accurate copy of print outs from each of the websites.

The foregoing coupled with copies of Applicants' Third Party Registrations should establish that the Cited Marks are weak and therefore afforded a narrow scope of protection. TMEP § 1207.01(d)(iii) (internal citations omitted) ("If the evidence establishes that the consuming public is exposed to third-party use of similar marks on similar goods, this evidence is relevant to show that a mark is relatively weak and entitled to only a narrow scope of protection.")

Even though some of third party marks referenced in Exhibit 1 and 2 and referenced in the Applicants' Third Party Registrations include other wording in addition to DASH, this evidence nevertheless establishes that the term DASH is commercially weak. The TMEP states, "[e]vidence of third-party use falls under the sixth *du Pont* factor – the 'number and nature of similar marks in use on similar goods.'" TMEP 1207.01(d)(iii) *citing to In re E. I. du Pont de*

*Nemours & Co.*, 476 F.2d 1357, 1361, 177 USPQ 563, 567 (C.C.P.A. 1973) (emphasis added). In other words, commercial weakness of a mark is not determined by whether there is third party use of the same mark, but of similar marks for similar goods. The TMEP further states, “[i]f the evidence establishes that the consuming public is exposed to third-party use of similar marks on similar goods, it ‘is relevant to show that a mark is relatively weak and entitled to only a narrow scope of protection.’ *Id* citing *Palm Bay Imps., Inc. v. Veuve Clicquot Ponsardin Maison Fondée en 1772*, 396 F.3d 1369, 1373-74, 73 USPQ2d 1689, 1693 (Fed. Cir. 2005) (emphasis added).

Additionally, even though some of the third party marks referenced in Exhibit 1 and 2 and referenced in the Applicants’ Third Party Registrations are used for related goods and services, at least twenty (25) of the third party marks referenced in Exhibit 1, twenty-nine (29) of the third party marks referenced in Exhibit 2 and sixteen (16) of the Applicants’ Third Party Registrations are used specifically in connection with apparel, eyewear and/or retail store services featuring apparel.

In cases where the cited senior marks are commercially weak, the Board has found in numerous cases that likelihood of confusion is not found due to the difference in the meaning and connotation of the marks, even despite the fact that the marks are identical and both used for apparel. *See, In re Sears, Roebuck & Co.*, 2 U.S.P.Q.2d 1312, 1314 (T.T.A.B. 1987) (finding no likelihood of confusion between CROSSOVER for brassieres and CROSSOVER for ladies’ sportswear as a result of their different meanings when applied to the goods of applicant and registrant, notwithstanding the fact that they are legally identical in sound and appearance); *In re British Bulldog, Ltd.*, 224 U.S.P.Q. 854, 856 (T.T.A.B. 1984) (finding no likelihood of confusion between PLAYERS for shoes and PLAYERS for men’s underwear due to the different connotations in the marks, one implying a shoe adapted to outdoor activities the other implies

something else “primarily indoors in nature”); *In re Sydel Lingerie Co., Inc.*, 197 U.S.P.Q. 629, 630 (T.T.A.B. 1977) (finding no likelihood of confusion between BOTTOMS UP for ladies and children’s underwear and BOTTOMS UP for men’s suits, coats and trousers due to the different connotations); *In re Shoe Works, Inc.*, 6 U.S.P.Q.2d 1890, 1891-1892 (T.T.A.B. 1988) (no likelihood of confusion between PALM BAY women's shoes and PALM BAY shorts and pants).

Furthermore, the TMEP specifically states, “[e]ven marks that are identical in sound and/or appearance may create sufficiently different commercial impressions when applied to the respective parties’ goods or services so that there is no likelihood of confusion.” TMEP 1207.01(b)(v). In the present case, the Applicants’ Mark is an abbreviation of KARDASHIAN, referring to the well-known sisters, Kim, Khloe and Kourtney Kardashian. *See*, Exhibit 1 of the first Office Action.

While the mark is not karDASHian, but rather DASH, the Board has long held that it and the examining attorney can go outside the four corners of the application and rely on extrinsic evidence to determine the meaning and connotation of an applicant’s mark. *See, e.g., In re Joint-Stock Company Baik*, 84 U.S.P.Q.2d 1921, 1923 (T.T.A.B. 2007) (relying on encyclopedia entry and dictionary definitions submitted by applicant to determine the connotation and primary significance of the mark BAIK to the purchasing public and reversing surname refusal); *In re Hamilton Bank*, 222 U.S.P.Q. 174, at 175-177 (T.T.A.B. 1984) (relying on extrinsic evidence submitted by applicant, e.g., third-party registrations and dictionary definitions, to determine the meaning, connotation, and strength of the mark KEY for banking services. The Board found the mark KEY was weak, thus applicant’s KEY mark was not likely to cause confusion); *In re Micro Instrument Corp.*, 222 U.S.P.Q. 252, 253-254 (T.T.A.B. 1984) (relying on two pieces of literature submitted by applicant that illustrated the nature of applicant’s goods and that the mark

MICRO had the connotation of precision work. Thus the Board found the mark was suggestive and capable of registration); *In Re Shop-Vac Corp.*, 219 U.S.P.Q. 470, 471-472 (T.T.A.B. 1983) (relying on extrinsic evidence provided by applicant, namely dictionary definitions, to determine the suggestive nature of the term BROOM for electric vacuums).

In looking at the extrinsic evidence provided by the Applicants, the Applicants' Mark is consistently used in connection with the name, image and/or likeness of the Kardashians, making it clear to consumers that DASH means KARDASHIAN. In stark contrast, the Cited Marks are never used in connection with the Kardashians and therefore, do not evoke the same meaning. In terms of reverse confusion, first, there is no evidence to suggest that consumers are being confused into thinking that the Cited Marks are associated with the Applicants' Marks, and second there is no evidence to support that the Applicants have so saturated the market, so as cause any likelihood of reverse confusion. *Sands, Taylor & Wood Co. v. Quaker Oats Co.*, 978 F.2d 947, 957, USPQ2d 1001, 1010 (7th Cir.1992) (The term "reverse confusion" has been used to describe the situation where a significantly larger or prominent newcomer "saturates the market" with a trademark that is confusingly similar to that of a smaller, senior registrant for related goods or services.) As a result of the highly distinguishable meanings of the relevant marks, consumers can easily differentiate between Applicants' Marks with the Cited Marks.

In sum, because the examining attorney raised a new issue and requirement, the Applicants believe that they have good cause to have the Applications remanded to the examining attorney and address the concerns first expressed in the Examiner's Appeal Brief. And, now having the opportunity to address the examining attorney's concerns

herein, the Applicants respectfully request that the applications be approved for publication.<sup>2</sup>
