On June 26, 2013, Attorney for Applicant respectfully requested an extension of time for filing a brief in the above-identified case, stating that an appeal brief is due July 1, 2013.

A similar request was made in application serial no. 85/555,607 for the mark ALL-WAYS FORWARDING (logo) (referred to herein as the "LOGO Application"). The extension request in this application was granted on June 27, 2013.

Both the pending application and the LOGO Application were under final rejection. Requests for Reconsideration were filed in both applications on March 28, 2013, simultaneously with a Notice of Appeal. Both requests for reconsideration were denied on April 14, 2013.

In LOGO Application the Appeal was reinstated on May 1, 2013, making the appeal brief due prior to July 1, 2013. Applicant assumed that the appeal in the pending case was reinstated on the

same date. However, when the Applicant's attorney reviewed the status on the USPTO website they found out for the first time that the appeal in the pending application was reinstated on April 15, 2013, thus making the appeal brief due prior to June 15, 2013.

Applicant respectfully requests that due to the circumstances above, and that the filings of both applications were done at the same time, the applicants request for an extension of time in this application be treated as timely and granted.
