I, the applicant and owner, D.S.T., application number: 85718981 do hereby object to the Request for Extension of Time to Oppose, by Ninkasi Brewery, LLC. (# ESTTA543976) I understand that I received the notice after the approval for the 30 days had already been granted, and this may be treated as a Request for Reconsideration. I hereby respectfully object to this extension of time, and object to any further extension of time for the following reasons:

Reasons thereof are: The applicant as well as an outside attorney, along with the examiners of this original application, being Cathryn Coward, and Fong Hsu, have conducted a complete and thorough review, and have found no conflicting marks relative to Babylonian or Babylonian Hooch. That being foremost, furthermore:

The applicant and an outside attorney have reviewed all subject matter, including Ninkaski Brewery LLC.'s line of products, such as: the Flagship Series, Seasonal Release Series, Prismatic Lager Series, Special Release Series, Single-Hop Series, R&D Series, Archived Series and have reviewed all of said companies products online. We also reviewed their "Worship the Goddess" and "Helles Belles" recently issued Trademarks. We even searched through said opposing companies' beers, events, visits, blogs, about, merch, contact and resources, just to be sure in performing a good faith effort in checking for a conflict; simply *no potential "damage"* to said opposing companies mark or products even exists in the broadest sense.
