

NOTICE OF OPPOSITION

Opposer, Rhythm Holding Limited, a Samoa corporation, with a business address of Unit 7B, Yarley Commercial Building, 3 Connaught Road West, Hong Kong, hereby opposes registration of the mark RHYTHM AND BLUES that is the subject of application Serial No. 85900641, published in the Official Gazette on August 14, 2013, and requests that registration to Applicant be refused.

As grounds in support of its Opposition, Opposer asserts as follows:

1. Opposer, for several years and since long prior to any date of first use upon which Applicant can rely, has adopted and continuously used the term “RHYTHM” and “RHYTHM LIVIN” as a trademark for clothing, as more particularly set forth below.
2. Opposer is the owner of Registration No. 3,610,417 for the mark, RHYTHM, for “backpacks and day packs” (in Intl. Class #18), as well as “clothing, namely, shirts, t-shirts, shorts; headgear, namely, hats, caps” (in Intl. Class #25). This Registration is valid, subsisting, unrevoked, and uncanceled. Printouts from the Trademark Status & Document Retrieval (TSDR) database showing the current status and title of this Registration are attached hereto as Exhibit A.
3. Opposer is also the owner of Registration No. 3,884,199 for the mark, RHYTHM, for “Clothing, namely, footwear, athletic footwear, slippers, casual footwear, sandals; bathing suits and trunks, beachwear, swimwear, beach and bathing coverups, bermuda shorts, pants, polo shirts, slacks, sweatshirts, tank tops, tops, trousers, knit shirts, caps; sleepwear, namely, nightshirts, boxer shorts, undershirts” (in Intl. Class #25). This Registration is valid, subsisting, unrevoked, and uncanceled. Printouts from the Trademark Status & Document Retrieval (TSDR) database showing the current status and title of this Registration are attached hereto as Exhibit B.

4. Opposer is also the owner of Registration No. 3,890,579 for the mark, RHYTHM LIVIN, for “clothing, namely, bathing suits and trunks, beachwear, swimwear, T-shirts, shorts” (in Intl. Class #25). This Registration is valid, subsisting, unrevoked, and uncanceled. Printouts from the Trademark Status & Document Retrieval (TSDR) database showing the current status and title of this Registration are attached hereto as Exhibit C.

5. Applicant has filed a trademark application to register the mark, “RHYTHM AND BLUES” for “clothing and headwear, namely, sports shirts, t-shirts, and hats”, in Intl. Class #25. That application was filed on April 10, 2013, and was assigned Serial No. 85/900641.

6. Applicant’s mark so resembles Opposer’s previously used and registered marks, RHYTHM, as to be likely, when applied to the goods set forth in Applicants’ application, to cause confusion, mistake, or deception within the meaning of Section 2(d) of the Trademark Act, 15 U.S.C. §1052(d).

WHEREFORE, Opposer prays that the opposition be sustained and that registration to Applicant be refused.
