Pursuant to 37 CFR § 2.117 and Section 1213 of the Trademark Trial and Appeal Board (“Board”) Manual of Procedure, Applicant Unirush, LLC (“Applicant”) hereby moves to suspend Exparte Appeal No. 86129533. Applicant has filed and the Board has instituted Cancellation Proceeding No. 92062414 seeking cancellation for abandonment of U.S. Reg. No. 3277453 for 24 KARAT CARD owned by Samuels Jewelers, Inc., the very mark cited by the Examining Attorney as the sole basis for the refusal of registration of Applicant’s 24K RUSHCARD mark under Section 2(d).
