

NOTICE OF APPEAL

Notice is hereby given that Applicant appeals to the Trademark Trial and Appeal Board the refusal to register the mark depicted in Application Serial No. 86131208.

The refusal to register has been appealed as to the following classes of goods/services:
Class 001.

All goods and services in the class are appealed, namely: Plant extracts, namely, extracts of Bacopa and bacopa monnieri, used in the manufacture of food products, food supplements, dietary supplements and nutritional supplements

Class 005.

All goods and services in the class are appealed, namely: Medicinal dragees, namely, medicated candies and sugar-coated medicines in pill form; homeopathic medicines used to treat cognitive health and to support learning, memory and mental performance; medicines for human use to treat cognitive health and to support learning, memory and mental performance; medicines for the prevention of cognitive impairments; medicines in tablet and capsule form used to treat cognitive health and to support learning, memory and mental performance; herbal compounds for medicinal use to treat cognitive health and to support learning, memory and mental performance; herbal dietary supplements for persons special dietary requirements; herbal extracts for medicinal purposes; herbal medicine used to treat cognitive health and to support learning, memory and mental performance; herbal preparations for medicinal use; herbal preparations for medicinal purposes; herbal preparations for use in medicine; herbal remedies, namely, preparations to improve cognitive health and to support learning, memory and mental performance; herbal tea for medicinal use; medicinal herbal infusions to improve cognitive health and to support learning, memory and mental performance; medicinal herbal preparations for medical purposes; extracts of Bacopa and Bacopa monnieri for medicinal purposes, all of the above expressly excluding medicated chewing gum
