

"STUMPJUMPERS MOTORCYCLE CLUB" because there is no likelihood of confusion between the marks. Since I am unsure whether potential opposer in fact did send in to TTAB a notice of withdrawal of extension of time, I am providing a copy of this letter to TTAB. Please note that the second Extension of time is due to expire on 1/28/2015, while the letter is dated 12/5/2014, which leaves over a month and half of void extension time. Therefore, in the interest of fair play and substantial justice, I am requesting that the remainder of the Extension Time be terminated and voided pursuant to the withdrawal by potential opposer as stated in their attached letter. I submit that in view of the withdrawal of the remainder of the extension of time it is procedurally appropriate to terminate the proceedings in this case.

Applicant requests that the Board immediately terminate the proceedings as to extension of time and direct the issue Applicant's registration of the mark.


