On November 9, 2015, Applicant requested that this Board suspend action in the instant matter pending a final determination in Cancellation No. 92062553. The cancellation proceeding was filed against Registration No. 1030589 (the “conflicting mark”), cited by the Trademark Examining Attorney as a Section 2(d) bar to registration of the mark.

Applicant’s petition to cancel the conflicting mark was granted on February 16, 2016, and Registration No. 1030589 was to be cancelled in due course.
