#### REQUEST FOR RECONSIDERATION OF FINAL DECISION

The following is submitted in support of a Request for Reconsideration of a Final Office Action issued on December 7, 2015 (the "Final Office Action"), concerning the application (the "Application") in the name of DNC Services Corporation ("Applicant") to register the mark I WILL VOTE & Design (the "Mark") in Class 35. In order to further preserve its rights, Applicant has contemporaneously filed a Notice of Appeal with the Trademark Trial and Appeals Board ("TTAB") with the filing of this response.

#### I. AMENDMENTS

#### A. Amendment to Services

The Examining Attorney has requested clarification of the description "voter registration services, namely, providing on-line voter registration forms services" on the basis that the description is allegedly too broad and references services that may be in multiple international classes. In response, Applicant amends the description of services as follows (added language shown <u>underlined</u> and language removed shown <del>stricken out</del>):

**Class 35:** Providing a website featuring information for voters, namely, voter registration information, polling locations, voting requirements and general voting information in the nature

of information online about political issues, elections and voting registration requirements; voter registration services, namely, providing on-line voter registration forms services

## Class 42: Providing a web site featuring technology that enables users to complete voter registration forms on-line

Applicant believes that the amendments above should be acceptable because they clarify the original identification, do not expand or add different services to the original identification, and conform in large part to the Examining Attorney's suggestions. 37 C.F.R. § 2.71(a); TMEP § 1402.06. Together with these amendments, Applicant further submits the requisite filing fee for the additional class, the dates of first use anywhere and in commerce, and a specimen of use for the services in Class 42. The specimen was in use in commerce on or in connection with the services listed in the application at least as early as the filing date of the application.

#### B. Amendment to Description of the Mark

The Examining Attorney has requested that Applicant amend the description of the Mark to describe all significant aspects of the applied-for mark. Accordingly, Applicant amends the description of the Mark as follows, in conformance with the Examining Attorney's suggestion (added language shown underlined and language removed shown <del>stricken out</del>):

The mark consists of the words "I WILL" in stylized lettering inside a small parallelogram with one curved side followed by the word "VOTE" in stylized lettering with the letter "V" representing a check mark.
