


To Whom It May Concern:

SECOND REQUEST FOR EXTENSION OF TIME TO OPPOSE

Petitioner hereby requests this Honorable Board to grant Petitioner its second request of sixty days to oppose the above SKIPPY applications, under 37 C.F.R. §2.102 (c)(3).

There are extraordinary circumstances involving the legal history, dating to the 1905 Act, when Applicant's predecessor in 1934 was denied the right to register Petitioner's corporate trade name for peanut butter. That final decision was ignored by applicant, *Skippy, Inc. v. Rosefield Packing Co., Ltd.* Opposition No. 13,134, under the then statutory Name Clause, §5(b), as amended. Rosefield, in defiance of Petitioner's prior rights, registered the identical name under the Lanham Act, Reg. 0504,940 in 1948, which Applicant claims to own as assignee, since 2013. The PTO file of Opp. 13134 was "destroyed in error" in 1965-66, which destruction (or theft) created extreme prejudice to Petitioner's meritorious claims and prior attempts to cancel Reg. 0504,940 (in 1980-82; 1986 and 2001-2005).


