REQUEST FOR RECONSIDERATION

Applicant hereby respectfully requests reconsideration of the Final Office Action issued on July 1, 2015 in light of the remarks and evidence submitted herein. Applicant is submitting an appeal to the Trademark Trial and Appeal Board concurrently with this Request for Reconsideration.

REMARKS

I. Background

On November 11, 2014, the Examining Attorney issued an Office Action refusing registration of Applicant's mark FIXE and Design ("Applicant's Mark") in Class 43 based on an alleged likelihood of confusion with registrations for the marks FIX and FIX (Stylized) in Class 43 (collectively, the "Cited Marks" or the "Cited Registrations"), owned by HHH Holdings, LLC (the "Registrant").

On May 26, 2015, Applicant responded to the Office Action and argued that Applicant's Mark is unlikely to be confused with the Cited Marks. In support of its arguments, Applicant submitted numerous third-party registrations for marks that incorporate the term FIX and cover restaurant services, as well as internet evidence showing that many unaffiliated businesses are providing restaurant services under a mark consisting of or incorporating FIX, in order to prove that the term "FIX" is suggestive and diluted in the context of the Registrant's services, and therefore the Cited Registrations should only be entitled to a narrow scope of protection. Applicant argued that the overall differences between Applicant's Mark and the Cited Marks in sight and meaning were more than sufficient to preclude consumer confusion in view of the extensive evidence showing that the Registrant's Mark was weak.

On July 1, 2015, the Examining Attorney issued a Final Office Action maintaining the refusal to register Applicant's Mark. In the Final Office Action, the Examining Attorney dismissed the probative value of the evidence of the dilution of "FIX" made of record by Applicant by simply asserting that "the other registrations with the word FIX contain additional wording and create

different commercial impressions than the marks at issue,” and that third party registrations are entitled to little weight on the question of likelihood of confusion. The Examining Attorney notably did not address in the Final Office Action the extensive internet evidence of third party uses in commerce of marks consisting of or incorporating “FIX” submitted by Applicant.

The Examining Attorney also dismissed Applicant’s arguments that its Mark differs in sight and meaning from the Cited Mark by noting that word portions of composite marks are typically considered the dominant feature of the mark, and therefore “the marks are sufficiently similar in their entireties that confusion as to the source of the services is likely to result because the recollection of the average purchaser will be that of FIX(E).” The Examining Attorney did not address in the Final Office Action Applicant’s assertions that Applicant’s Mark and the Cited Mark have very different meanings when considered in the context of the parties’ services.

Applicant respectfully submits that the Examining Attorney’s refusal of Applicant’s Mark is improper in view of the evidence and arguments made of record by Applicant, particularly in light of the recent guidance that was provided by the Federal Circuit after the issuance of the Final Office Action. Accordingly, the refusal of Applicant’s Mark should be withdrawn.

II. Recent Precedent from the Federal Circuit Compels the Conclusion that Applicant’s Mark is Not Confusingly Similar to the Registered Marks

Following the Examining Attorney’s issuance of the Final Office Action, the Federal Circuit issued two precedential opinions that are directly relevant to the present application, and that squarely support the arguments against likely consumer confusion that Applicant submitted with its previous response.

In *Juice Generation, Inc. v. GS Enterprises LLC*, 115 USPQ2d 1671 (Fed. Cir. 2015), the Federal Circuit determined that the Board erred in concluding that there was a likelihood of confusion between the applied-for mark PEACE LOVE AND JUICE and Design for juice bar services and several registrations for marks consisting of or incorporating PEACE & LOVE covering restaurant services owned by an opposer. The Board had reasoned that confusion was likely despite the visual differences between the marks because the term “PEACE LOVE” was the dominant portion of each mark. *Id.* at 1673. The Board also found the evidence submitted by the applicant of extensive third party use and registration of marks incorporating PEACE & LOVE to not have much probative value, since the applicant did not provide “specifics regarding the extent of sales or promotional efforts surrounding the third-party marks and, thus, what impact, if any, these uses have made in the minds of the purchasing public.” *Id.* at 1674.

On appeal, the Federal Circuit concluded that the Board did not properly consider whether the third party evidence submitted by the applicant showed that the terms PEACE and LOVE were weak and diluted in the industry, and therefore the cited marks should be entitled to only a narrow scope of protection. The court instructed:

sufficient evidence of third-party use of similar marks can show that customers...have been educated to distinguish between different...marks on the basis of minute distinctions....More broadly, evidence of third-party use bears on the strength or weakness of an opposer's mark...The weaker an opposer's mark, the

closer an applicant's mark can come without causing a likelihood of confusion and thereby invading what amounts to its comparatively narrower range of protection.

Id. (internal quotations and citations omitted). The court acknowledged that the applicant may not have proven the extent and impact of use of the third parties' marks, but this evidence standing alone was "nonetheless powerful on its face." *Id.* The court further recognized that:

[t]hird party registrations are relevant to prove that some segment of the composite marks which both contesting parties use has a normally understood and well recognized descriptive or suggestive meaning, leading to the conclusion that that segment is relatively weak....Marks that are descriptive or highly suggestive are entitled to a narrower scope of protection, *i.e.*, are less likely to generate confusion over source identification, than their more fanciful counterparts.

Id. at 1675 (internal quotations and citations omitted).

Turning next to the Board's comparison of the marks at issue, the Federal Circuit concluded that the Board did not adequately consider whether the applicant's mark "may convey a distinct meaning—including by having different connotations in consumers' minds" from the cited marks. *Id.* at 1676. The court also found that, while the Board may properly afford more or less weight to a particular component of a mark for appropriate reasons, a proper likelihood of confusion analysis must view each mark as a whole and give significance to each element of the marks at issue in determining whether consumers are likely to be confused. *Id.* The Federal Circuit held that the Board's analysis asserting that the dominant portions of each mark were confusingly similar was not "sufficient to demonstrate consideration of the mark as a whole." *Id.*

Shortly after issuing its opinion in *Juice Generation*, the Federal Circuit again reversed the Board and concluded that the Board did not properly consider evidence of third party use in determining that consumer confusion between two marks was likely. In *Jack Wolfskin Ausrüstung Fur Draussen GmbH & Co. KGAA v. New Millennium Sports, S.L.U.*, 116 USPQ2d 1129 (Fed. Cir. 2015), the Federal Circuit reviewed the finding by the Board that an applied-for design mark resembling a paw print was likely to be confused with a registration that consisted of the term KELME and a paw print, given the similarities between the designs and the overlap between the goods. The court noted that the applicant had presented "voluminous" evidence of paw print design elements that have been registered and used in connection with clothing. *Id.* at 1136. However, the Board had discounted this evidence based on the axiom that third-party registrations are not evidence that the identified marks are in use, and by asserting on the differences between the third party designs and the designs at issue justified how those designs could peacefully co-exist with the cited mark, but the applicant's mark could not. *Id.*

The Federal Circuit determined that the Board had "erred in its consideration of this [third party] evidence." *Id.* The court reasoned that:

[Applicant] presented extensive evidence of third-party registrations depicting paw prints and evidence of these marks being used in internet commerce for clothing. The Board too quickly dismissed the significance of this evidence. As we recently explained in *Juice Generation*, such extensive evidence of third-party use

and registrations is “powerful on its face,” even where the specific extent and impact of the usage has not been established....In this case, [Applicant's] evidence demonstrates the ubiquitous use of paw prints on clothing as source identifiers. Given the volume of evidence in the record, consumers are conditioned to look for differences between paw designs and additional indicia of origin to determine the source of a given product. [Applicant's] extensive evidence of third-party uses and registrations of paw prints indicates that consumers are not as likely confused by different, albeit similar looking, paw prints. The Board's conclusion that this factor was neutral is not supported by substantial evidence.

Id. at 1136.

In the months since the Federal Circuit issued its opinions in *Juice Generation* and *Jack Wolfskin*, the Board has acknowledged the precedential weight of these opinions and has repeatedly overturned refusals by Examining Attorneys where the evidence of record shows that the term(s) shared by a registrant's mark and an applicant's mark are diluted and/or suggestive in the context of the goods or services at issue. For example:

- *In re SDI Petroleum, LLC*, Serial No. 86/011,946 (TTAB November 30, 2015) (non-precedential) (no likelihood of confusion between DASH NEIGHBORHOOD and DASH IN despite overlap between services, since applicant provided examples of “at least 17 uses of ‘DASH’ in connection with convenience store services” and “consumers will look to slight differences in the marks, and although their commercial impressions are somewhat similar, the differences in sight and sound are sufficient, given the weakness of DASH for these services”).
- *In re Colorbar Cosmetics Private Limited*, Serial No. 86/323,815 (TTAB November 20, 2015) (non-precedential) (finding no likelihood of confusion between applicant's mark COLORBAR USA and registered marks THE COLOR BAR and CB COLORBAR THE SALON and Design since the evidence of “widespread third-party use” of COLORBAR provided by the Applicant was “powerful and more than sufficient to show that the terms COLOR BAR and COLORBAR are weak as source indicators for services such as those of Registrants.”).
- *In re Dignity Health*, Serial Nos. 85/473,422, 85/484,353, 85/486,297 and 85/486,308 (TTAB September 17, 2015) (non-precedential) (no likelihood of confusion between DIGNITY HEALTH and DIGNITY CONTINENCE SOLUTIONS since “the term DIGNITY is inherently weak when used in connection with healthcare services and this weakness is compounded by the evidence of third-party use of DIGNITY-formative marks in connection with healthcare-related service....Thus, on the record before us, we find that the similarity between the marks based on this common term is lessened and consumers are likely to pay attention to the additional, albeit descriptive, wording for purposes of distinguishing the marks.”).
- *In re Vulcanic*, Serial Nos. 79124238 and 79124239 (TTAB September 3, 2015) (non-precedential) (“Extensive evidence of third-party use and registrations may be

probative in showing that a term is weak and that customers have been educated to distinguish between different marks on the basis of small distinctions.”).

Applicant respectfully submits that the Examining Attorney’s analysis in the Final Office Action is very similar to the analysis of the Board that the Federal Circuit found to be inadequate in *Juice Generation* and *Jack Wolfskin*. The Final Office Action does not sufficiently consider (or, in some cases, even appear to consider at all): (1) the numerous third party registrations and uses in commerce of marks consisting of or incorporating “FIX” in the context of restaurant services, (2) the highly suggestive meaning of “FIX” in this context, (3) the differences between Applicant’s Mark and the Cited Marks in meaning, and (4) the overall differences between Applicant’s Mark and the Cited Marks in commercial impression when each mark is considered as a whole. Accordingly, Applicant submits that a proper analysis of Applicant’s Mark in view of the Federal Circuit’s recent guidance and the evidence of record as supplemented with this Request for Reconsideration shows that consumer confusion between Applicant’s Mark and the Cited Marks is simply unlikely to occur.

III. The Term “Fix” is Highly Suggestive and Diluted in the Context of Restaurant Services

The evidence of record shows that the term FIX is in use by many unaffiliated businesses in the marketplace offering bar and restaurant services and closely similar services. For example, the following registrations are for marks incorporating “FIX” and covering bar and restaurant services and are owned by entities other than the Registrant:

TSDR records for the above-cited registrations are attached as **Exhibit A**. Applicant again notes that the registrations for BOBA FIX, CHILE FIX, and THE WING FIX are all able to peacefully co-exist on the Principal Register with the Cited Marks despite the fact that these marks merely consist of the Cited Mark and a generic term for a food product (presumably the type of food product offered by the registrant at its restaurant). This is evidence that the Patent and Trademark Office has repeatedly concluded that the Cited Marks are entitled to such a narrow scope of protection that even the addition of just a generic term to these Marks is sufficient to preclude consumer confusion. Applicant notes that the Registrant did not oppose the registration of any of the above-cited marks, which shows that even the Registrant believes that the addition of a generic term to "FIX" is enough to prevent consumers from being confused.

While the Examining Attorney is of course not bound by the decisions of other Examining Attorneys and every case must be determined on its own merits, Applicant notes that the Board and the Federal Circuit have noted on many occasions that consistency in examination is a goal of the Office. *In re Rodale Inc.*, 80 USPQ2d 1696, 1700 (TTAB 2006); *In re Consolidated Cigar*, 35 USPQ.2d 1290, 1295 (TTAB 1995). Thus, the Office's goal of consistency in examination weighs towards the Examining Attorney not breaking from the established practice of other Examining Attorneys unless the evidence of record with respect to a particular mark strongly favors such a break. Applicant respectfully submits that the evidence of record as supplemented by this Request is entirely in favor of a finding against likely consumer confusion, and therefore the Examining Attorney should follow the established Office practice and not place Applicant at a commercial disadvantage with respect to its competitors.

As further evidence of the highly diluted nature of FIX in the context of the services of Applicant and the Registrant, a brief internet search reveals at least the 29 following businesses that are offering bar or restaurant services under marks that consist of or incorporate "FIX":

Website print-outs for the above-mentioned businesses are attached hereto as **Exhibit B**. In addition, as shown in the evidence attached hereto as **Exhibit C**, these businesses have received hundreds or thousands of consumer reviews and “likes” on Facebook, which proves that the relevant purchasers of the services of the Registrant and Applicant are familiar with other users of marks incorporating “FIX” with bar or restaurant services.

Applicant notes that the Federal Circuit in *Juice Generation* concluded that at least 26 uses or registrations of marks incorporating PEACE and LOVE supported a finding that these terms were weak in the context of the services at issue. *Vitasoy International Holdings Limited v. Caffè Vita, Inc.*, Opposition No. 91214495 (TTAB November 30, 2015) (non-precedential) (“the third-party evidence here appears less voluminous than that in *Juice Generation*, which addressed at least 26 uses or registrations.”). Moreover, the Board in *In re SDI Petroleum, LLC* concluded that “at least 17 uses of ‘DASH’ in connection with convenience store services” were sufficient to show that the term was weak for the services. Thus, Applicant’s submission of over 30 uses and registrations of marks consisting of or incorporating “FIX” in connection with bar or restaurant services conclusively establishes that the Cited Marks are weak in the Registrant’s industry, and therefore entitled to only a very narrow scope of protection.

First, the Board and the Federal Circuit have repeatedly concluded that marks that are highly suggestive of a feature or characteristic of the identified goods or services are weak marks entitled to only a narrow scope of protection, and third party registrations and uses are probative to whether a term has a normally understood and well recognized descriptive or suggestive meaning in the industry. *See, e.g., Juice Generation, Inc.* at 1675 (Fed. Cir. 2015); *Drackett Co. v. H. Kohnstamm & Co.*, 404 F.2d 1399, 1400 (CCPA 1969) (“The scope of protection afforded such highly suggestive marks is necessarily narrow and confusion is not likely to result from the use of two marks carrying the same suggestion as to the use of closely similar goods). Here, the use by multiple unrelated businesses of marks consisting of or incorporating “FIX,” including many marks that merely consist of “FIX” and the generic word, is evidence that “FIX” is well-understood by consumers in this context as meaning “an amount of something that somebody needs.” Thus, “FIX” is highly suggestive of an attractive feature of the services offered by businesses using this mark with restaurant services (*i.e.*, that the food served by the restaurant will satisfy the consumer’s needs or allow them to get their “fix”).

Second, the evidence of widespread use and registration of marks consisting of or incorporating “FIX” in the marketplace with restaurant services shows that consumers have become accustomed to encountering different users of this highly suggestive term in this context. Accordingly, consumers have been educated to distinguish between different marks incorporating “FIX” on the basis of small distinctions. Again, Applicant notes that the Cited Marks co-exist on the Principal Register and in the marketplace with marks that consist of the term “Fix” and a generic, non-distinctive term such as “The,” “Restaurant,” “Boba,” “Chile,” “Wing,” “Coffee,” “Sushi,” and “Burger.” The distinctions between these marks and the Cited Marks that are sufficient to permit the marks to peacefully co-exist are much less significant than the distinctions between Applicant’s Mark and the Cited Marks in sight, sound, and meaning.

As reaffirmed by the Federal Circuit in *Juice Generation* and *Jack Wolfskin*, a proper likelihood of confusion analysis requires clear consideration of each mark as a whole, and some significance must be given to each element of a mark even if this element is not alleged to be the “dominant” portion of the mark. Applicant respectfully submits that a proper comparison of Applicant’s Mark and the Cited Marks in view of the Federal Circuit’s recent precedential decisions and the very weak nature of “FIX” as established by the evidence submitted herein leads to the conclusion that the marks present very different overall commercial impressions when considered in their entireties.

IV. Applicant’s Mark Differs From the Cited Marks in Meaning

As discussed above, the evidence of record (including the dictionary evidence previously submitted by Applicant) shows that “fix” is understood in the Registrant’s industry as a highly suggestive noun meaning “an amount of something that somebody needs.” This meaning is very different from the vague, refined meaning presented by the term “FIXE” in Applicant’s Mark. As noted by the Examining Attorney and confirmed by Applicant, the term “fixe” translates into the adjective “fixed,” which means “not subject to change or fluctuation” or “having a final or crystallized form or character.” Applicant’s Mark when translated consists of an adjective standing alone that does not modify a verb or noun, which results in Applicant’s Mark presenting a vague, nebulous meaning that consumers will need to use thought and imagination to comprehend. Many consumers that associate Applicant’s Mark with the adjective “fixed” will understand the Mark as describing that Applicant’s restaurant provides a settled or definitive style of cuisine and service, and Applicant does not need to change and fluctuate to keep up with the latest industry trends in order to provide outstanding meals and keep its customers satisfied. Consumers that primarily associate Applicant’s Mark with the term “fixed” are also likely to understand that Applicant’s Mark is suggestive of the fact that Applicant provides old-fashioned, time-tested cuisine that is “fixed” in time. Notably, the slow, inactive meaning presented by the term “fixed” is a direct opposite to the active, quick meaning presented by the term “fix.”

Other consumers will understand that Applicant’s Mark is referencing the term “FIXE” in the well-known phrase “prix fixe,” which means a style of service featured at many refined and renowned restaurants. Such consumers will recognize Applicant’s Mark as suggesting that Applicant shares the same level of sophistication and quality as the types of restaurants that offer “prix fixe” service. Finally, many consumers that are not aware of the translated meaning of “FIXE” will simply understand the mark as a coined term that does not have any meaning other than as a source identifier.

Accordingly, Applicant submits that Applicant’s Mark incorporates an entirely different term than the Cited Marks, and as a result consumers will associate Applicant’s Mark with a meaning that is easily distinguishable (and in some respect, completely opposite) of the meaning presented by the Cited Marks. Moreover, Applicant again stresses that the Examining Attorney must consider the impact on the meaning of Applicant’s Mark created by the large, stylized acorn design that dominates the visual space of Applicant’s Mark, as well as the presentation of the term “fixe” in elegant, stylized font in the Mark. These elements reinforce the commercial impression of sophistication and timelessness presented by the term “FIXE” in Applicant’s Mark, and there is simply no component of the Cited Marks that presents a commercial impression of an acorn or the

elegance and sophistication of the script in Applicant's Mark. In addition, acorns present meanings and associations to consumers that are both literal (such as oak trees, squirrels, or acorn-based food products) and metaphorical (such as the fact that many great endeavors grow from small, modest beginnings similar to the way a tree grows from an acorn), and as a result consumers will associate Applicant's Mark with meanings specific to the acorn design that will not be elicited by the Cited Marks.

V. Applicant's Mark Differs from the Cited Marks in Sight and Sound

Applicant further asserts that the visual differences between Applicant's Mark and the Cited Marks are significant and more than sufficient to preclude consumer confusion. In the Final Office Action, the Examining Attorney dismisses the visual differences between Applicant's Mark and the Cited Marks by simply referencing the precedent that the word portion of a composite mark "*may* be more likely to be impressed upon a purchaser's memory and to be used when requesting the services," and therefore the dominant elements of both marks is the term "FIX[E]." (emphasis added). As noted above, even assuming *arguendo* that "FIXE" is the dominant portion of Applicant's Mark, this term still presents a dramatically different meaning from the term "FIX" comprising the Cited Marks.

Moreover, the Examining Attorney does not provide evidence or arguments beyond a simple citation that in this particular case "FIXE" is the dominant portion of Applicant's Mark, particularly in view of the diluted and highly suggestive nature of the term "FIX" in this context. As the Board recently stated, "while it is often true that the words in a composite word and design mark are considered to be dominant, that is not always the case." *In re Covalinski*, Serial No. 85/685,983 (TTAB December 18, 2014) (non-precedential) (reversing Examining Attorney and

finding no likelihood of confusion between REDNECK RACEGIRL and Design  and RACEGIRL since "we find that the overall commercial impression of Applicant's mark is dominated by its design features...and that this weighs heavily against a conclusion that confusion is likely.").

Applicant again notes that one recent Board decision featuring similar facts is particularly instructive for the present case. In *In re Fairview Import Corp.*, Serial No. 85/395,780 (TTAB August 16, 2013) (non-precedential), the Board considered whether the applied-for mark HERITAGE COLLECTION and Design appearing below was likely to be confused with the word mark HERITAGE 1981 when both marks are being used for identical goods.



The Examining Attorney asserted that the marks were confusingly similar since they both featured the term HERITAGE and allegedly merely descriptive terms. The Board first noted that the evidence of record indicated that HERITAGE was a weak term in the context of the goods at issue. Turning to the visual impressions created by the marks, the Board concluded:

the marks are dissimilar to a significant extent in that applicant's mark contains the prominently sized and arbitrary design of a moose. This design contributes greatly to the visual impression of applicant's mark. This is not a case in which the design portion of applicant's mark is an easily overlooked geometric carrier or an abstract pattern that is much smaller in size than the wording. We observe that in registrant's mark the term HERITAGE is the first and most prominent portion thereof. However, in applicant's mark, the term HERITAGE is located below the prominent moose design, which is equal in size to the wording HERITAGE COLLECTION and appears to be arbitrary as applied to the goods....Taken as a whole, the marks thus are different in connotation and commercial impression.

Id. at *10-11.

Similar to *Fairview Import*, the present case involves the comparison of a word mark with a composite mark that features a large, distinctive design that dominates the visual space of the mark. Moreover, the Cited Marks are extremely weak in the context of the Registrant's services, and therefore entitled to a thin scope of protection. Thus, even if consumers associated the same overall meaning between "FIXE" and "FIX," which Applicant strongly contends is not the case for the reasons discussed above, then following the reasoning of the Board in *Fairview Import* the significantly different visual impressions presented by Applicant's Mark and the Cited Marks are more than sufficient to preclude any alleged consumer confusion in view of the very weak nature of "FIX" in the context of the services at issue.

In addition, while consumers that are aware of the pronunciation and meaning of "fixe" may pronounce Applicant's Mark the same as the Cited Marks, other consumers unfamiliar with the term are likely to pronounce Applicant's Mark phonetically as "fix-ee," or "fix-ay." The TMEP instructs that "for purposes of the §2(d) analysis, there is no 'correct' pronunciation of a mark because it is impossible to predict how the public will pronounce a particular mark." TMEP § 1207.01(b)(iv). Therefore, just as an applicant may not rely upon a "correct" pronunciation to avoid a likelihood of confusion, the Examining Attorney here cannot rely on the "correct" pronunciation of Applicant's Mark to claim that Applicant's Mark is aurally similar or identical to the Cited Marks. Accordingly, Applicant's Mark will present a distinguishable aural impression than the Cited Marks to at least some consumers that encounter Applicant's Mark, and the consumers that will pronounce "FIXE" and "FIX" the same are the consumers most likely to understand the dramatic differences between these terms in meaning.

VI. Summary of Arguments Against a Likelihood of Confusion

In sum, Applicant respectfully submits that the recent precedential decisions of the Federal Circuit clearly mandate that the Examining Attorney should withdraw the refusal to register Applicant's Mark based on an alleged likelihood of confusion with the Cited Marks. The evidence made of record by Applicant conclusively establishes that the term "FIX" is highly suggestive and diluted in the context of the Registrant's services, and therefore the Cited Marks should be entitled to only a narrow scope of protection. This narrow scope of protection does not extend to Applicant's Mark when each mark is considered as a whole, given that Applicant's Mark presents a

meaning and visual impression that is very different from the impression presented by Cited Marks. Accordingly, under the precedent of the Board and its reviewing court, the refusal to register Applicant's Mark is improper and should be withdrawn.

CONCLUSION

For all of the foregoing reasons, Applicant respectfully requests that the refusal to register Applicant's Mark be withdrawn, and that this application be allowed to proceed to publication. The present Response is intended to address all issues outlined by the Examining Attorney. If there is an issue that can be resolved by an Examiner's Amendment, the Examining Attorney is invited to contact Applicant's attorney.
