

MOTION TO DIVIDE APPLICATION

Applicant Lauren Braun, by counsel, files this Motion to Divide Application, and in support states:

1. Applicant filed her trademark application on October 21, 2014 seeking registration in Classes 005 (pharmaceutical goods), 014 (jewelry), 041 (education), and 044 (medical services).

2. On November 4, 2015, the examining attorney issued a final office action denying registration in all four classes.

3. On May 3, 2016, Applicant initiated an appeal and also filed a Request for Reconsideration. The appeal was stayed pending the resolution of the Request for Reconsideration.

4. On June 6, 2016, the examining attorney found that all requirements for Classes 041 and 044 (the “service mark” classes) had been satisfied, but upheld the previous denial of Classes 005 and 014 (the “goods mark” classes). Accordingly, this appeal only proceeds with respect to Classes 005 and 014.

5. Pursuant to TMEP § 1110.09, Applicant now moves this Board to divide Classes 041 and 044 from the appeal and allow the application on those marks to proceed to registration.

6. Enclosed with this Motion to Divide Application is a fee as required by 37 C.F.R. § 2.6(a)(20).


