

2. On August 6, 2002, Genesis filed a Motion to Resume Proceedings advising the Board and MHSC that the bankruptcy which resulted in the suspension of these proceedings had been concluded.

3. Subsequent to Genesis' filing of its Motion to Resume Proceedings, counsel for Genesis and for MHSC began to engage in settlement negotiations in an attempt to resolve this matter.


4. In addition to Genesis' emergence from bankruptcy, ownership of the mark formerly held by MHSC was assigned to a third-party, VHS Genesis Labs, Inc. These events lead the parties to believe that there is an increased likelihood for a negotiated resolution of this matter.

5. VHS Genesis Labs, Inc., to whom MHSC assigned all of its rights in the mark at issue, is filing a Motion to Substitute concurrently with this motion.

Accordingly, MHSC and its successor-in-interest, VHS Genesis Labs, Inc., respectfully request that the Board suspend the above-captioned proceedings for a period of ninety (90) days so that the parties may further explore settlement of this matter.


