In an order dated July 14, 2000, the Board granted applicant's motions to amend its dates of use and to amend the identification of goods in application Serial No. 75/006,342. Applicant was informed that republication was required in view of the amendment to the dates of use. In addition, the parties were further informed that consideration of the stipulated withdrawal of the opposition, contingent upon entry of the amendment to the identification of goods, would be deferred pending appropriate action by the Office of the Commissioner for Trademarks regarding the inadvertently issued registration of application Serial No. 75/006,342.

Custom-ordered point of purchase displays using fiber optic cables arranged in patterns to create various designs of customers in light.

Said amendment is hereby entered.
