Applicant also hereby moves for an extension of its time to answer or move with respect to the Notice of Opposition, namely, up to, and including, August 12, 2002.


The parties have exchanged settlement proposals and appear close to reaching a settlement. Applicant is presently considering opposer's revised proposed settlement agreement.
