STIPULATED MOTION TO EXTEND DISCOVERY AND TESTIMONY PERIODS

Opposer and Applicant in the above-identified Opposition, by and through their respective attorneys, hereby stipulate that the discovery and testimony periods set by the Board may be extended for a period of sixty (60) days. In view of recent developments regarding the settlement negotiations in which the parties have been engaged, the parties urge the Board *not* to re-suspend these proceedings for an extended period of time; the parties believe that an extension of the discovery period and testimony periods each by the requested 60 day period may be sufficient to further their mutual ends.

The request is made in good faith and not for mere delay. As a result of fundamental changes in the parties' positions or circumstances, the extension is necessary to allow the parties sufficient time to discuss the possibility of settlement under significantly different terms.

September 2, 2002


Rebuttal testimony period to close:

For the reasons set forth above, Opposer and Applicant respectfully request that the Board grant the requested extension of time.




