As a follow up to our voicemail exchanges yesterday and in view of your absence today at the Trademark Trial and Appeal Board (the "TTAB"), I am writing to enclose photocopies of the original paperwork and confirmation of the TTAB's receipt of our correspondence filed on October 22, 2001 in connection with the above-mentioned matter, which you had indicated had not been received and/or logged into the system regarding OPPOSITION NUMBER 121,358.

On October 22, 2001, our client, Relocation Resources International, Inc. 

In support of this motion, Applicant states:






