**SAVITAR'S MOTION FOR
EXTENSION OF TIME IN WHICH
TO CONDUCT ITS DISCOVERY**

Comes now the Applicant, Savitar Corporation ("Savitar"), and moves this Board to extend the time period in which it has to conduct discovery. In connection with its motion, Savitar states the following:

1. This Board determined that discovery shall be completed by August 16, 2002.
2. On March 8, 2002, Savitar served interrogatories and requests for production on Opposer. Opposer failed to fully answer the discovery. After failing in its attempts to have Opposer reconsider its objections, on June 13, 2002, Savitar filed its Motion To Compel Documents From Opposer.
3. This Board has not yet ruled on Savitar's motion. However, it is anticipated that the Board will grant, if nothing else, at least part of the motion.

4. Savitar should be permitted to conduct follow-up discovery after it receives the compelled discovery from Opposer, especially since this discovery was originally served over five months ago.

WHEREFORE, Applicant, Savitar Corporation, prays that this Board enter an order extending the time in which Savitar has to conduct written discovery and for all other just and proper relief on the premises.
