Further to our telephone conversation a few moments ago, the extension requests we filed for the referenced application are attached, as well as our November 30, 2001 fax to Ms. Millicent Canady. Both extension requests were filed timely. We did not receive any correspondence from the TTAB regarding these requests. The first request had the correct serial number in the text, but the incorrect serial number in the caption due to a typographical error.
