DECLARATION OF VASUKI SELVAN IN SUPPORT OF APPLICANT'S MOTION FOR SUMMARY JUDGMENT

I, Vasuki Selvan, hereby declare as follows:

1. I am a trademark paralegal at the law firm of Legal Strategies Group, counsel of record for Applicant Joel Barry Shamitoff in this opposition proceeding. Among my duties is the performance of trademark research. I have personal knowledge of the facts stated herein and, if called as a witness, could and would testify thereto.

2. On or about January 15, 2003, I performed a search of the U.S. Patent & Trademark Office (U.S. PTO) database using LEXIS database software. Specifically, I requested records of any trademarks, registered or pending, using the term "MONSTER" in International Class 28 owned by Monster Cable Products, Inc. The results of my search indicated that there were no pending or registered trademarks incorporating the term "MONSTER" owned by Monster Cable Products, Inc. in International Class 28.

3. On or about January 15, 2003, I performed a further search of the U.S. Patent & Trademark Office (U.S. PTO) database using LEXIS database software. Specifically, I requested records of registered and/or renewed trademarks in International Class 28 using the term "MONSTER" and not owned by Monster Cable Products, Inc. The results of my search indicated the existence of over 45 registrations and/or renewals in International Class 28 incorporating the term "MONSTER" and not owned by Monster Cable Products, Inc. Copies of those registrations are attached hereto as Exhibit A.

4. On or about January 24, 2003, using the GOOGLE search engine, I performed a search on the Internet for products related to United States trademark registrations in International Class 28 that incorporate the word "MONSTER." My search indicated that many of these registered trademarks are currently being used in connection with a variety of toys. I printed out a number of pages from the Internet that I found during the course of my search; these printouts are attached hereto as Exhibit B.

5. On or about January 24, 2003, I performed a search of the U.S. Patent & Trademark Office (U.S. PTO) database using LEXIS database software. Specifically, I requested records of registered and/or renewed trademarks using the term "MONSTER" in International Classes 6, 9, 16, 25, 41 and 42, not owned by Monster Cable Products, Inc. The results of my search indicated that in these classes, there are at least 125 registered and/or renewed trademarks not owned by Monster Cable Products, Inc. and incorporating the term "MONSTER."

6. On or about January 24, 2003, I performed a further search of the U.S. Patent & Trademark Office (U.S. PTO) database using LEXIS database software. Specifically, I requested records of registered and/or renewed trademarks using the term "MONSTER" and not owned by Monster Cable Products, Inc. without limitation as to International Class. The results of my search indicated the existence of over 275 registrations and/or renewals incorporating the term "MONSTER" and not owned by Monster Cable Products, Inc.

7. On or about March 26, 2003, I reviewed Monster Cable Products, Inc.'s web site at www.monstercable.com. Information available on the Monster Cable Products web site


indicates that Monster Cable Products goods and services include a variety of electronic cable products available at numerous locations in the United States, Canada and abroad. Indeed, the home page of the web site displays the message "Taking Electronics to the Next Level of Performance." The web site characterizes the company as "the world's leading manufacturer of high performance cables that connect audio/video components for home, car and professional use as well as computers and video games" and "striving to discover and develop new, advanced technologies and designs to meet the needs of the . . . consumer electronics industry." My review of the Monster Cable Products website produced no indication or evidence that Monster Cable Products offers plush toys in association with any of its products. Printed pages from the Monster Cable Products web site are attached hereto as Exhibit C.

8. Attached hereto as Exhibit D is a chart which was attached as Exhibit A to Opposer's Responses to Applicant's First Set of Interrogatories, dated February 28, 2003.

9. On or about March 26, 2003, I performed an Internet search using the GOOGLE search engine. The parameters of my search included the terms "MONSTER," "TOYS" and "PLUSH." My review of over 39 pages of results produced evidence of the use of "MONSTER" on a large number of plush toys offered for sale by various vendors. Printouts of some of these web sites and the products offered thereon are attached hereto as Exhibit E.

I declare under penalty of perjury under the laws of the United States that the foregoing is true and correct.
